6. RESULTS OF THE ANNUAL ADMISSION CONSULTATION 2004/05

The Director for Education Services submitted a report (copies of which had been circulated) detailing the outcome of the annual consultation on admission arrangements at maintained primary and secondary schools in the Borough for the academic year 2004/05.

An amendment to annexe 3, appendix 1 to the report was reported detailing revised figures for nett capacity assessments in respect of Dial Park Primary School from 262 to 238 and a consequent amendment to the indicated admission number from 37 to 34 which would put the school below the proposed admission limit of 35.

RESOLVED - (1) That the Executive be advised:

(i) To determine admission limits for 2004/05 at community and voluntary control primary schools as proposed in appendix 1, annexe 3 of the report and to publish notices in the local newspaper in respect of the following schools:-

- (iv) To amend the admissions criteria for Bramhall High School to include:

Identified pupils with sensory impairment who meet the criteria for a place at the school to have the same level of priority as those who live in the priority area for the school.

(v) Not to proceed with the formal introduction of a Co-ordinated Scheme for Secondary School Admissions

for 2004/05 but to pilot the scheme on an informal basis.

- (vi) That the Council's Executive be requested that any merger proposal at Great Moor School should be considered at the School Admission Forum after the consultation and prior to any proposed merger being decided upon.
- (2) That the Governing Bodies of Voluntary Aided Primary and Secondary Schools be advised:
- (i) To determine the admission limits for 2004/05 as suggested in Appendix 1, Annex 4 of the report and to publish notices in the local newspaper in respect of the following schools:
 - North Cheshire Jewish Primary School and St Christopher's Primary School;
- (ii) Of its support for the proposed changes to the admission policy in respect of Looked After Children as detailed in the report and its concern to ensure that all Voluntary Aided schools address this issue.
- (iii) Of its support for the proposed changes to the admissions policy at Cheadle Catholic Infant School and Cheadle Catholic Junior School and that North Cheshire Jewish School (subject to its addressing the priority for Looked After Children); and
- (iv) To advise the Executive that it should respond to these consultation items in the same manner.
