A representative of the Head of Area Governance outlined the procedure approved by the Council for public speaking on planning applications.

A representative of the Service Director (Transportation & Planning) reported that plan nos. 42328 and 42329 had been resubmitted to the Committee to allow for the consideration of an objection which that Committee had not had the opportunity to review or hear at its last meeting.

#### Town Centre Committee – 16 December 2009

The representative of the Head of Area Governance reported that both the objector and the applicant's agent were present at the meeting, however, as the applicant's agent had taken the opportunity to speak in support of the application at the last meeting, any further contributions on behalf of the applicant could only be made in response to specific points raised by the objector.

In respect of plan no. 42328 for the erection of a new community hospital (Class D1) with ancillary uses including a community cafe, pharmacy and community facilities with access, parking and associated works at St Thomas' Hospital, Shaw Heath,

a member of the public spoke against the applicant; and

the applicant's agent made a comment in response to one of the points raised by the objector.

It was then

RESOLVED - That the Service Director (Transportation & Planning) be authorised to determine the application subject to the completion of negotiations and the signing of the appropriate Highways agreements.

In respect of plan no. 42329 for the demolition of all curtilage listed buildings to make way for the erection of a new community hospital (listed building consent) at St Thomas' Hospital, Shaw Heath,

It was

RESOLVED – That the Service Director (Transportation & Planning) be authorised to determine the application.
