A brief history

- Originated as the GP Co-Operative in 1996
- Mastercall Healthcare established in 2004 (GP opt-out)
- Accredited Social Enterprise organisation providing a range of innovative services across the Greater Manchester and the North West

'Out of Hospital' Services we provide in Stockport:

- GP Out of Hours Service
- Community IV Therapy Service
- GP Pathfinder (Alternative to Transfer) scheme
- NHS Dental Helpline
- Clinical session at the Wellspring Centre/Stockport Hostels
- Practice cover including Protected Training Time



Why did we decide to move?

- Diversification and extension of services means the building is no longer fit for purpose
- Restricted capacity in current premises to improve facilities and expand
- Insufficient consulting rooms to cope with increasing service activity during peak times
- Cramped waiting area
- Limited car parking spaces
- As a result, patient experience has been affected, including longer waiting times



The planning process...

- Early 2014 we we undertook an evaluation and options appraisal of premises available
- Most beneficial solution was to move all services to a new 'fit for purpose' site
- An extensive property search was carried out
- No suitable premises in Town Centre
- Most appropriate site available at the time was Pepper Road, Hazel Grove, Stockport, SK7 5BW
- The large space provided the luxury to design new & improved facilities for staff and patients.





What are the benefits of the new premises for patients?

An increase in:

- ✓ The number of consultation rooms from 7 to 10
- ✓ Waiting room capacity from 30 seats to 50 seats
- ✓ Parking spaces from 25 to 57 with use of the whole business park in the 'out of hours' period

Also...

- ✓ New children's area
- ✓ An extra isolation room
- Extended call centre facilities with a 'state of the art' IT & telephony infrastructure
- Extended office space and training suite
- Closer proximity to Stepping Hill Hospital for emergency referrals



Access to the new premises


- The new site is only 2.9 miles away from the old building
- 1 mile from the A6 in Hazel Grove

Transport Plan submitted as part of planning approval process


We are committed to ensure that patients do not have difficulty accessing our services

Patient Transport Service

- We provide a 'courtesy' patient transport service
- Current usage is 1.9% of patient contacts
- Wider usage to support medication delivery/knock-ons etc
- Capacity within the current PTS
- Can be complemented by taxi especially if needing DDA vehicles
- Eligibility criteria:
 - Health & Social Care
 - Parental supervision under the age of 16
 - Exclusion:
 - Intoxicated (drugs/alcohol)
 - History of violent/aggressive behaviour
 - Chest pain





Pharmacy provision...

- Currently in talks with Lloyds
 Pharmacy re setting up a dispensary
- Sainsbury is 1 mile from the new premises
- Mastercall have notified all local pharmacists regarding relocation
- We can dispense from our own stock
- Expressions of interest have been received from other pharmaceutical organisations










Upstairs Open Plan Office
