Church Rd / Ravenoak Rd Area - Traffic Regulation Order

Report of the Corporate Director for Place Management & Regeneration

1. INTRODUCTION AND PURPOSE OF REPORT

1.1 To report the findings of a consultation exercise and to seek approval for the introduction of a Traffic Regulation Order (TRO)

2. INFORMATION

- 2.1 The Ward Councillors have received a request for an investigation to be conducted into inconsiderate parking on Ravenoak Road, outside the Church Inn (PH), within the vicinity of Ravenoak Road / Ack Lane West / Church Road, roundabout.
- 2.2 The comments received inform that motorists using the inside lane on Church Road to turn left into Ravenoak Road at the roundabout, suddenly find themselves having to swerve to avoid parked vehicles.
- 2.3 Due to the nature of the concerns raised, Traffic Services consulted with the residents likely to be affected with the proposals, shown on Drawing Nos NM8-4927-01and NM8-4927-02
- 2.4 Due to the locality of the proposals 33 No letters were delivered of which we received 15 (45%) replies, of which 10 were in favour and 5 disagreed with the proposals
- 2.5 The ones who disagreed with the initial proposals made comment as follows:-
 - Can the council consider a minor addition by extending the parking restrictions
 past the entrance of 'All Saints Vicarage' as vehicles are parking very close making
 it difficult to see oncoming vehicles whilst exiting the driveway
 - The restrictions proposed will further damage the businesses as there are no restrictions outside of the shops and cars park all day preventing customers from visiting the shops.
 - Vehicles park on Vicarage Road very close to the junction with Church Road after the restriction times, making it difficult for vehicles to enter / exit and at times theirs potential head-on conflicts because of the parked vehicles. Can the restrictions be changed to 'No Waiting at Any Time'
- 2.6 Taking into account the objections received as outlined in paragraph 2.5, amendments have been made to the initial proposals which are shown on **Drawing No NM8-4927-03** and will be advertised if the proposals are agreed.

3. FUNDING
