All rooms have disabled access and the review has taken into consideration that there should be no barriers to voting for people with a disability. Mobile polling station at AB is DDA compliant.

AA – A request for properties to be removed from polling district AA to Cheadle Hulme North has been received. Advised unable to do this as part of a Polling District Review. This could only be changed via a Local Government Boundary Review.

AB - proposed housing development in the polling district will increase the electorate by approximately 400. The mobile building currently used would not accommodate two polling stations and no alternative buildings are available. It is proposed to re-draw the polling district boundary to include Barnes Village into polling district AE (Barnes Way, Worthington Crescent, Pennington Gardens, and Booth Square). The situation is to be monitored and if necessary provide two mobile buildings for future elections.

Comment that the map showing the location of polling station AB is in the wrong place – amended as part of the review.

AB - it is proposed to move the odd properties 7, 9, 11, Brookside Nursery Bungalow and The Aspens on Brookside Road from AF to AB to bring this in line with the even numbers on Brookside Road. This will increase the electorate by approximately 19.

**Re-draw polling district boundary AB to move Barnes Village into AE to bring the electorate to the optimum.**

**Re-draw polling district AF to move the odd properties, Brookside Nursery Bungalow and The Aspens into AB.**

The Area Committee expressed concern that residents in polling district JG walk past the Guywood Centre (polling station JD) to access their polling station at Romiley Methodist Church (JG). It is proposed to move the properties southwest of the train line from JG into polling district JC. The Guywood Centre will be used as a double station for JD and JG.

The residents of Heys Avenue in polling district JD have to walk past a polling station on their street which is for polling district JE (1<sup>st</sup> Romiley Scout Hut). It is proposed to move the properties from Heys Avenue, Heys Lane, Cornfield Road and Round Croft (properties 30 to 88 only) into polling district JE which will allow those electors to vote at Romiley Scout Hut.

The Area Committee requested that consideration be given to moving both sides of Bredbury Green into polling district JB. After consideration the Returning Officer proposes to move the even numbered properties in Bredbury Green from polling district JF to JB making the Overdale Children's Centre a double station.

**JG – Move the properties southwest of the train line from JG into polling district JC with electors voting at the Guywood Centre.**

**JD – Move Heys Avenue, Heys Lane, Cornfield Road and Round Croft (properties 30 to 88 only) into polling district JE with electors voting at Romiley Scout Hut.**

Following feedback from Councillors a proposal has been submitted to re-draw polling districts within Offerton Ward (U) and create a new Polling District (UG) and a new polling station at the Britannia Hotel. This will improve accessibility for voters.

**Redraw polling districts within the Offerton Ward creating a new polling district (UG) using the Britannian Hotel as the polling station.**
