## STRATEGIC COMMISSIONING: GETTING MORE OUT OF OUR SPENDING

Proposal 4: Community Safety Update
Lead Portfolio: Children's Services; Communities & Housing

#### 1. Summary of proposals

- 1.1. A review has been undertaken to understand the Community Safety Services delivered across Stockport.
- 1.2. The review has identified two areas where financial savings could be made by either changing or ceasing the service. The first element will review how antisocial behaviour and youth disorder is tackled within Stockport. This work is currently undertaken by a range of services within the Council, including Targeted Youth Services, Community Safety and Public Protection plus Stockport Homes and GMP. It is clear from initial review of processes that there is scope to alter working practices to improve the efficiency and targeting of cases.
- 1.3. The second strand has identified the potential to replace the security patrols currently undertaken by Totally Local Company on behalf of the Council with a reduced service. The current patrols maintain the security of Council owned buildings. Officers are working with Totally Local Company to alter this service to achieve savings, whilst still providing a responsive service where needed.

#### 2. Proposal Update

- 2.1. A review of the services in scope (Targeted Youth Services, Community Safety, Public Protection and Stockport Homes) has identified that there are potential efficiencies from organising work in a different manner. The alternative potential arrangements are being developed to meet the timetable in section 5.
- 2.2. Management of youth based disorder and anti-social behaviour has significantly improved in recent months with effective partnership working between the agencies in scope and GMP identifying perpetrators and taking a broad range of interventions to modify behaviours. Prior to this, there had been concerns within Stockport regarding youth disorder and anti-social behaviour, with an increase in incidents taking place within the town centre and parts of its fringe. It is proposed to build upon these strengthened partnership arrangements to continue to effectively manage youth anti-social behaviour and disorder whilst reducing the number of agencies involved in individual cases.

2.3. It is also proposed to reduce and rationalise the Council's security and patrols services currently undertaken across the Borough. The patrols protect Council owned assets rather than manage community safety matters across the borough and therefore residents will be unaffected by changes in arrangements. Officers have identified that it is possible to alter the nature of the responsive service without compromising the security of key assets.

#### 3. Scope

- 3.1. The following community safety activity is in scope of these proposals:
  - · Public Safety and Protection,
  - · Youth Offending Service,
  - Anti-Social Behaviour and Community Safety responsibilities across the organisation,
  - Security and patrols.
