1. INTRODUCTION AND PURPOSE OF REPORT

- 1.1 To update the Area Committees and the Cabinet Member on progress of the NPIF schemes at:
- A560 Stockport Road/M60 Junction 2 'Roscoes' Roundabout;
 - Abney Hall Park Path and Path Links to Manchester Road;
 - A560 Stockport Road/High Street/Manchester Road Junction.

2. INFORMATION

- 2.1 The Council has been granted funding from the Department for Transport to provide a package of measures on the A560 corridor to provide congestion relief, enhance access to employment, improve bus reliability, safety and facilitate active travel. The package of measures is split into three schemes, which include M60 Junction 2: Roscoes Roundabout; Scheme, Abney Hall Park Path & Paths to Manchester Road and A560 Stockport Road/Manchester Road Junction. In addition there is a project to link signals along the A560 Corridor on the SCOOT system. This will entail some ducting works for linkages between signals and changes to electronics within the signal controller.
