Paul Clarke (Public Realm Inspector) attended the meeting to report on current issues and to answer questions from councillors and members of the public in relation to public realm issues within the area represented by the Cheadle Area Committee.

## Cheadle Area Committee - 24 September 2019

- It was raised whether a schedule of regular locations with overhanging vegetation could be compiled.
- The problem of cars parking on the grass verge on Ladybridge Road, Cheadle Hulme continued to be a problem.
- The street cleaning of Lorna Grove, Gatley appeared not to be continuing and needed rectifying.
- There was overgrown vegetation opposite Cheadle Mosque on Wilmslow Road, Heald Green which needed attending to.

## (vi) Ward Flexibility Funding - 5th Cheadle Hulme Scout Group

A representative of the 5<sup>th</sup> Cheadle Hulme Scout Group attended the meeting to present an application for Ward Flexibility Funding to purchase some flood defences for its building.

## 9. ROAD SAFETY AROUND SCHOOLS - ETCHELLS PRIMARY SCHOOL, HEALD GREEN

A representative of the Deputy Chief Executive submitted a report of the Corporate Director for Place Management and Regeneration (copies of which had been circulated) regarding the findings of a consultation exercise for Road Safety around Schools –

Etchells Primary School, Heald Green and seeking approval to the introduction of Traffic Regulation Orders, associated signage and bollards.

South east side, from a point 10 metres north east of the north easterly kerb line of Cheadle Road for a distance of 33 metres in a north easterly direction to the Access Road.

(2) That approval be given to the statutory legal advertising of the Traffic Regulation Order and, subject to no objections being received within twenty one days from the advertisement date, the Order be made.
