## Report of the Corporate Director for Place Management & Regeneration

## 1. INTRODUCTION AND PURPOSE OF REPORT

To approve the placement and costs for pedestrian barriers on part of St Elisabeth's Way in Reddish.

## 2. BACKGROUND

Network Management received representation from the office of the local MP acting on behalf of a constituent. The matter related to reports of motor scooters / bikes using the passage at the southerly (cul-de-sac) end of St Elizabeth's Way and related concerns for the welfare of pedestrians.

# 3. PROPOSALS

Please see the attached sketch drawing (Number: **NM18-6318**) for the placement of staggered barriers to prevent the reported activity.

# 5. CONSIDERATION OF ALTERNATIVE SOLUTIONS

Network Management would have reservations about the placement of staggered barriers for the reasons below:

- This estate has a network of interconnecting passages and the provision of staggered barriers at this location may establish a precedent where the Council would be expected to provide the same treatment elsewhere (at considerable cost).
- Staggered barriers can be a nuisance for mobility scooters as the user has to negotiate the 'obstruction'.

The Ward Spokesperson upon being notified of these reservations still felt that the proposal should go ahead as barriers has proved effective at other locations.

## 6. CONSULTATION

If the scheme is approved, local residents will be notified well in advance before any works are carried out on site.

# 7. FINANCIAL IMPLICATIONS

The associated cost for the attached works (Inc. removing the existing posts) would be £410 funded from the delegated Ward Budget.

# 8. TIMESCALES

If approved, the work should be completed on site in the earlier part of next year.
