Range Road	Residents parking scheme reviewed due to maintenance. Objection report deferred at the meeting of the Area Committee held on 10 August 2017 for reconsideration.
Crosby Street (Well Grove – Adswood Lane East)	Residents Parking Petition – awaiting decision on Davenport and Cale Green Permit Parking Zone before proceeding.
Wellington Grove	Residents Parking Petition reported to the Area Committee. Awaiting decision on Davenport and Cale Green Permit Parking Zone before proceeding.
Davenport and Cale Green Permit Parking Zone	Proposed Permit Parking Zone. Drop in meeting arranged for 31 October 2018. Awaiting details re businesses. Consultation documents sent out in June. Report submitted to the September meeting of the Area Committee. Sent to Legal Services for advertising. Legal notices to be placed from 22 January 2020 for three weeks. Objections received and to be reviewed between May and August.

Lowfield Road	Petition for one-way. Historical reasons for removing one way 20-30 years ago and wider impact on HGVs on Range Road etc. Draft plans sent to Councillors. To be discussed in Winter 2019/20 to see if scheme progressed or no further action.
East Street	Proposed waiting restrictions. Consultation to be prepared July 2019. Comments received from Stockport Homes to be considered.
Ward Street	Proposed Waiting Restrictions – report submitted to the Area Committee. Sent to Legal Services for notices in March/April. To be combined with Jones Square Traffic Regulation Order. Objection report submitted to the November meeting of the Area Committee. No objections received, works to be ordered and to be checked on site between May and August.
Jones Square	Proposed waiting restrictions. Report submitted to the January meeting of the Area Committee. Combined with Ward Street Traffic Regulation Order. Objection report submitted to the November meeting of the Area Committee. No objections received, works to be ordered and to be checked on site May-/August.
Voewood House	Rationalise existing restrictions. Site visits done to check existing markings and signs September/October. Traffic Regulation Orders to be rationalised – plans to be drawn up May-August.
Toronto Road	Proposed Waiting Restrictions. Consultation documents to be prepared August/September 2019. Report submitted to the last meeting of the Area Committee. Legal notice onsite. Objections received and to be reviewed May-August.
Old Chapel Street/Bulkeley Road	Proposed Waiting Restrictions. Report submitted to November meeting of the Area Committee. Instructions sent to Legal Services February 2020 for advertising March/April. Traffic Regulation Order advertised with no objections. Instruction sent to contractors. Works to be ordered between May and August.
Charles Street	Proposed Waiting Restrictions. Currently out to consultation until 20 September 2019. Consultation results sent to Councillors. Swept path vehicle tracking plans to be drawn up prior to report being prepared for the Area Committee between May and August.

St. Petersgate	Proposed Pay and Display. Plans drawn up 7 October 2019. Traffic Regulation Orders to be rationalised. Funds to be requested from Strategic Budget. Consultation letter and plan sent with an end date of 15 November 2019. Results to be reviewed March – April 2020. Traffic Order to be rationalised. Funds to be requested from the strategic budget.
Ilfracombe Road/Woodlands Drive	Proposed Waiting Restrictions. Consultation and plans sent with an end date of 29 November 2019. Results to be reviewed May-August 2020.
Myrtle Street	Proposed Waiting Restrictions. Plans approved – consultation letter and plan sent to residents on 31 October 2019 with an end date of 15 November 2019. This scheme is to be incorporated into local Town Centre Access Plan projects.
Oakfield Road	Road Safety Improvement. Consultation letter sent to residents 26 September 2019 with a return date of 18 October 2019. Consultation results sent to councillors.
Culver Road	20 mph Markings. Scheme to be investigated January - March as part of the 2019/20 Road Safety around Schools Programme.
Hempshaw Lane – Battersby Hat Works site	Traffic Regulation Orders as part of the redevelopment. Report to be submitted to the March meeting of the Area Committee. Next stage to progress between May and August.
