# **Greg Street, Reddish**

Report of the Corporate Director for Place Management & Regeneration

## 1. INTRODUCTION AND PURPOSE OF REPORT

To approve an experimental order for No Waiting and No Loading restrictions on part of Greg Street in Reddish.

### 2. BACKGROUND

Members will be aware of the recent experimental order for No Waiting and No Loading covering that part of Greg Street adjacent to Three Acres Drive. The order was deemed necessary to address environmental concerns and related issues associated with a premises on Greg Street.

With regard the extent of the restrictions, Network Management were very conscious of not extending the order any further than it needs to be as this removes available space for 'legitimate' parking in a commercial area. In this case, we were not aware of any complaints from the occupants at No's 41 & 43 Three Acres Drive which are located some 90 metres or more from the premises in question.

Further to the implementation of the current order, there has been observed a displacement of parking (with related environmental issues) towards the rear of the said properties. This in turn is causing some consternation for the residents.

For the sake of expediency and in agreement with the Ward Councillors, a decision has been made to implement another experimental order to prohibit waiting and loading on Greg Street at the rear of these properties.

## 3. PROPOSALS

The proposal is delineated on the attached sketch drawing number: **NM8-4663-001B**. The restriction will extend to a point 3 metres past the adjacent public footpath.

### 4. LEGAL POSITION/IMPLICATIONS

The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

## 5. CONSULTATION

As and when the order is made, local residents and premises will be notified and will have opportunity to return a formal objection during the experimental period.

### 6. FINANCIAL IMPLICATIONS

To be funded from the delegated Ward budget.

### 7. TIMESCALES

If approved, the experimental order could be implemented on site in October / November 2020.
