Report of the Corporate Director for Place Management & Regeneration

1. INTRODUCTION AND PURPOSE OF REPORT

- 1.1 Traffic Services have been instructed by the Highway Ward Spokesperson for Marple South and High Lane to legally advertise a moving traffic regulation order for 'No Motor Vehicles Except for Access' on to Thornway, Beechway, Daisy Way and Meadway.

2. BACKGROUND

- 2.1. A report was submitted in September 2019 which was approved to consult with local residents on the proposed traffic regulation order. This was delayed due to a wider consultation in High Lane to understand residents' concerns on the wider area due to the opening of the A555.

3. PROPOSALS

- 3.1. It is proposed to introduce a 'No Motor Vehicles Except for Access' Traffic Regulation Order (TRO) on Meadway, Daisyway, Beechway and Thornway as shown on attached drawing NM8/5139/Thornway-Meadway/01.

4. LEGAL POSITION/IMPLICATIONS

- 4.1. The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

5. CONSIDERATION OF ALTERNATIVE SOLUTIONS

- 5.1. No other alternatives were considered, for consideration refer to background papers.

6. CONSULTATION

- 6.1. Due to the delay from the approved September 2019 report for expediencies, the consultation will be conducted simultaneously with the legal advertisement.

7. FINANCIAL IMPLICATIONS

- 7.1. The cost to the Marple South delegated ward budget (2019-2020 already approved) Consultation, including signs on street required for motorists using this route, £1,500. Legal Advertising £800 Site works for signage at four entry points: £1,800 - Total £4,100

8. TIMESCALES

8.1. Subject to no objection, installation early 2021.
