## (ii) DC075414 - 132 Ack Lane East, Bramhall

In respect of plan no. DC075414 for the demolition of existing conservatory and detached garage; proposed two-storey side extension including a hip to gable roof extension on both sides to facilitate a loft conversion and creation of 3rd storey (the roof alterations include an increase in ridge height, additional windows to side and rear elevation and rooflights to the rear roofslope); proposed single storey rear extension and a single storey porch to front elevation; and proposed additional vehicular parking with additional presscrete driveway at 132 Ack Lane East, Bramhall,
