- 1.1 To report the findings of a Parking Survey carried out over a number of months on Vaudrey Drive, Cheadle Hulme.

3. BACKGROUND

- 3.1. Traffic Services received a request for a Residents Parking Scheme to be implemented on Vaudrey Drive, Cheadle Hulme; this was due to a petition submitted by residents and request made by the Highway Ward Spokespersons. However, as the properties all have off-road parking the location failed to meet the required criteria.
- 3.2. Traffic Services agreed to carry out a Parking Survey as it was reported that residents were unable to park due to the volume of 'none' residents parking at the location and that access to and from residents' driveways were also being hindered by these parked vehicles. It was further reported that vehicles were parking on the bend in the road causing an obstruction and safety concerns for other road users.
- 3.3. Traffic Services Officers attended the location at a variety of different times and days including weekends and evenings. The results of the findings are provided in the chart below:
