Dialstone Lane

North East side from a point 10 metres South East of the South Easterly kerb line of Biddulph Avenue for a distance of 9 metres in a South Easterly direction (and to tie in with Existing).

North Westerly side from the South Westerly kerb line of Dialstone Lane for a distance of 25 metres (following the kerb line) in a South Westerly direction.

Report of the Corporate Director for Place Management & Regeneration

1. INTRODUCTION AND PURPOSE OF REPORT

To approve No Waiting at Any Time restrictions on Dialstone Lane and Hornbeam Close in Great Moor.

2. BACKGROUND

Members will be aware of the redevelopment of the former Cherry Tree Hospital site into residential properties. In relation to this, the Development Control Team approached Network Management to recommend the provision of a Traffic Regulation order (TRO) for parking restrictions on Hornbeam Close at the junction with Dialstone Lane.

3. PROPOSALS

Please see attached drawing number: 4244-001 and the comments below:

- The restrictions will serve to prevent conflict and congestion amid traffic turning in and out of Hornbeam Close along the approach to Dialstone Lane.
- The drawing shows the legal extent of the TRO into Hornbeam Close. As and when the double yellow lines are implemented on site, they will be tailored to suit the bell mouth entry into Cherry Tree House.
- The proposal also includes extended No Waiting restrictions on Dialstone Lane on the southerly arm of the junction at Biddulph Avenue. This is to prohibit parking on a stretch which can seriously hinder visibility of approaching traffic for householders exiting their driveways.

4. LEGAL POSITION/IMPLICATIONS

The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

5. CONSULTATION

A local public consultation (delivered in August 2020) has not resulted in any adverse responses.

6. FINANCIAL IMPLICATIONS

The associated cost for the TRO will be funded by the Developer as part of the planning conditions.

7. TIMESCALES

If approved the order is expected to become operative in early 2021.
