CORPORATE RISK REGISTER 2020/21 - UPDATE

Report of the Corporate Director, Corporate and Support Services and Deputy Chief Executive

1. INTRODUCTION AND PURPOSE OF REPORT

- 1.1 The Corporate Risk Register (CRR) was last updated and distributed to Audit Committee on the 4th August 2020.
- 1.2 The CRR reflects the changes to the Council's overall risk profile as follows:
 - A new corporate risk (13) titled "Pandemic" was added at the last update. Whilst this inevitably includes the risks still posed by the current outbreak and continuing restrictions it is intended to include the risks posed by the "second wave" or indeed totally new pathogen in the future.
 - The financial risk (2) has been redrafted in light of the significant challenges posed by the pandemic on the Council's financial position.
 - Minor updates, drawn from commentary in the Annual Governance Statement 2020 around the impact of Covid19 on other risk areas, particularly Social Care restructuring (7&8) and Growth (11).

2. CONCLUSIONS AND RECOMMENDATIONS

2.1 The Audit Committee is asked to comment on the current corporate risks identified in the Register.
