Proposed scheme to alter the traffic calming measures along Greg Street

Report of the Corporate Director for Place Management & Regeneration

1. INTRODUCTION AND PURPOSE OF REPORT

1.1 To provide information to the Area Committee and to seek approval from members regarding the proposed traffic calming measure alterations along Greg Street, following the feasibility study that was carried out.

2. BACKGROUND

- 2.1. This report follows on from the previous report 'Greg Street, Reddish' which was submitted to the Heatons & Reddish Area Committee Meeting on 20th July 2020 and subsequently RESOLVED That the Area Committee has:- (2) Given approval to the undertaking of a feasibility study at a cost of £750 to be funded from Area Committee's Delegated Budget (Reddish South ward allocation) into providing engineered carriageway markings on that part of Greg Street from the junction at Hibbert Street to Reddish Road.
- 2.2. The Feasibility and Road Safety Team have been commissioned by the Heatons & Reddish Area Committee to carry out a feasibility study to identify what traffic calming measures would be appropriate and the estimated costs.
- 2.3. Residents have expressed concerns about the speed of vehicles between Hibbert Street and the northerly part of Reddish Road. Despite there being no traffic incidents recorded by GM Police on these sections within the last three years, a speed survey in 2016 (near Jewson's premises) identified an Average 85% speed of 36.6mph (i.e. 15% of traffic was moving at above this speed). This reading is unusually high and therefore further measures could be deemed justified.
- 2.4. Feasibility work has been undertaken to determine the viability of different traffic calming options that could prove to be effective when implemented along Greg Street.
- 2.5. A site visit of the existing road layout for Greg Street has been carried out. Any observation that was relevant to the scheme was noted and used as guidance for assessing the different options.

3. PROPOSALS

- 3.1. They have then been individually assessed on their feasibility, and a cost of each option has been estimated. Further details of the feasibility study can be seen in the attached FEASIBILITY STUDY REPORT 4272 Greg Street, Reddish. All the scheme costs provided for each option in this report may change during the detailed design stage of the project.
- 3.2. Typically traffic calm measures were all tabulated together as potential methods to propose for this scheme. The viability of each measure was determined based on

the observations of the area explained in the attached *Traffic Calming Measure Options - Greg Street Feasibility*.

3.3. From carrying out the feasibility work a total of four different layouts are being proposed, as shown in the table below in 3.4.

1	F/4272/001	White centre lining from outside Dace Motor Company to Hibbert Street (approximately 750m).	£2,025.00
2	F/4272/002	Revoking and adding sections of yellow lines and introduction of staggered onstreet parking bays on both sides of the road.	£3,240.00
3	F/4272/003	Combination of Option 1 and Option 2.	£5,265.00
4	F/4272/004	Eight sets of speed cushions along Greg Street from outside Dace Motor Company to Hibbert Street.	£54,000.00

4. LEGAL POSITION/IMPLICATIONS

4.1. The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

5. CONSULTATION

5.1. Further consultation will be required with the following stakeholders as mentioned in the attached *FEASIBILITY STUDY REPORT 4272 – Greg Street, Reddish.*

6. FINANCIAL IMPLICATIONS

- 6.1. As part of their delegated budget, Reddish South Ward have approved funding of £750.00 to carry out this feasibility study to identify what traffic calming measures would be appropriate.
- 6.2. There are four options with individual scheme costs for each proposal; which would be funded by the Reddish South Ward Budget, if approved. Option 4 would be likely to require a bid for funding however there is no designated Capital funding for traffic calming schemes at this time.

7. EQUALITIES/COMMUNITY IMPACT ASSESSMENT
