Introduction to sailing course for 10 to 16 year olds. Three courses, starting 02/04/2021.
Funding required to upgrade sailing equipment.

10. Who will benefit from this grant?

Local children aged 10 to 16 will learn to sail single handed dinghies. We are running a series of courses starting on 02/04/2021.

10(a) How Many Stockport residents will benefit?

25 to 30 children are expected to take the course; 10 children (max) will attend each which will take place during spring and summer 2021. We anticipate that most of the children will be Stockport residents.

10(b) Are there any restrictions on who will benefit from the funding?

No. ECPSC is an inclusive sailing club

11. Your Project's Budget

To run the course safely, we need to upgrade the fleet of dinghies we use for training. We anticipate replacing rigging (ropes and cleats), sails where necessary, foot straps, and rudders, tillers and centre-boards where necessary

11(a) How much will the project/activity cost in total?

We have budgeted £2000 for the overall upgrade project. A new sail costs between £150 and £375, cleats are upward of £20 each, and centreboards and rudders are £80 each.

11(b) Tell us about other any other sources of income you have already applied for or raised so far in relation to this project

The club is providing all facilities and equipment – boats, wetsuits, life jackets, helmets, plus instruction on and off water. Safety boat cover will be provided and an RYA Senior Instructor will be present at all times. Other services (catering, first aid, reception duties) will be provided by club members and volunteers. We will fund the boat upgrade programme for our own resources - membership fees and fund raising events held during the year - plus any grant income



12. How much are you applying for from the Ward Flexibility Budget?

£1000 – 50% of the programme's budget.

The upgrade programme will be reduced in its scope and quality if we do not have full funds. Sails are the biggest cost within the budget; It is most likely that they would not be replaced if funding was not available
