1. MINUTES

The Minutes (copies of which had been circulated) of the meeting held on 15 November 2010 were approved as a correct record.

2. DECLARATIONS OF INTEREST

No declarations of interest were made.

3. COMMUNITY ENGAGEMENT

(i) Chair's Announcements

The Chair reported that the 'Pride in the Heatons & Reddish Awards' would be held on Monday, 7 March 2011 at 6.30pm in the Town Hall Ball Room and invited Councillors and members of the public to submit nominations to Democratic Services for the following categories by Friday, 11 February 2011:-

- Beyond the Call of Duty at Work (for excellent customer service)
- Contribution to Sport
- Environment Champion
- Keeping Streets Safe
- Volunteer of the Year
- Carer of the Year

(ii) Neighbourhood Policing

PCSO Chris Noble (Greater Manchester Police) attended the meeting to answer questions from Councillors and members of the public in relation to Neighbourhood Policing issues within the Brinnington & Reddish Wards. The following issues were raised / comments made:-

- PC Jane Rendell and PCSO Chris Noble had taken over responsibility for the Reddish Vale area from PC Lee Scott.
- Ongoing incidents with off road biking and usage of air rifles in the vicinity of Reddish Vale Country Park.
- The mobile police unit had recently been deployed within Reddish Vale Country Park to combat anti social behaviour.
- Notices had been placed in Reddish Vale Country Park in an attempt to discourage anti social behaviour relating to sexual activity.

RESOLVED – That PC Chris Noble be thanked for his attendance.

(iii) Public Question Time

Members of the public were invited to submit questions on any matters within the powers and duties of the Ward Committee, subject to the exclusions set out in the Code of Practice.

One public question was submitted asking which Council service was responsible for the installation of grit bins in Reddish Vale Country Park.

A representative of the Service Director (Communities) explained that the land in question on Reddish Vale Road was an unadopted highway and therefore the Highways Department would not grit the road. The Communities department (Parks, Sport and Cemeteries) was responsible for gritting the section of the road owned by Parks. It was felt that installing a grit bin on the road was not viable because there was a risk that the grit could be stolen as this had happened at several locations in the borough last winter.

RESOLVED - (1) That the report be noted.

(2) That the Service Director (Legal & Property) be requested to attend the next Joint Ward Committee to discuss the legal status of Reddish Vale Road.

(iv) Petitions

No petitions were submitted.

(v) Area Flexibility Funding

A representative of the Head of Area Governance reported that there were no applications to consider.

4. REDDISH VALE COUNTRY PARK RANGER UPDATE

A representative of the Service Director (Communities) submitted a report (copies of which had been circulated) summarising the public events which had taken place at Reddish Vale Country Park and the number of other incidents and achievements during the period from October 2010 to December 2010. The following comments / issues were made:-

- Excellent attendance figures in October and November 2010 although the bad weather had affected visitor numbers and events during December.
- Ongoing partnership working with the Probation Service.
- Ongoing incidents with off road biking in the vicinity of Reddish Vale Country Park.
- Theft of three metal barriers on the Trans Pennine Trail, Reddish Vale Country Park.
- Working closely with Greater Manchester Police to combat anti social behaviour.
- The possibility of whether a small centre could be built at Tiviot Way which would act as a deterrent for anti social behaviour in the vicinity of Reddish Vale Country Park.
- Discussions were ongoing with partners regarding a bicycle hire scheme at the Visitors' Centre.

 The CBeebies filming that was carried out last year at the Community Garden in Reddish Vale Country Park had been broadcast. A display at the Visitor Centre about this had been put together with help from Phil Kinsey.

RESOLVED – That the report be noted and that Alexandra Krause and the Reddish Vale Country Park volunteers be thanked for their effort and hard work at Reddish Vale Country Park.

5. THE LEGACY LEFT BY MR FRANK BRAMWELL TO STOCKPORT COUNCIL

A representative of the Service Director (Communities) submitted a report (copies of which had been circulated) detailing suggestions for how the legacy bequest by Mr Frank Bramwell for South Reddish Park and Reddish Vale Country Park could be spent. The following comments were made/ issues discussed:-

- The proposal to install a Multi Use Games Area (MUGA) and a retractable canopy for the bowling pavilion for South Reddish Park had been well received by the 'Friends of South Reddish Park'.
- Strongly suggested that a memorial plaque would be a good way of commemorating Frank Bramwell's legacy eternally in South Reddish Park and Reddish Vale Country Park.
- Expressed support for the 'wetland creation' project, 'Mill Lane / Visitor Centre triangle' improvement project, 'Sunnyside pond dipping platform' replacement scheme and the 'bottom reservoir wildlife habitat' improvements.
- Sunnyside Woods restoration project was well received and a request for the area to be made more accessible for disabled visitors and replanting of bluebells was recommended.
- It was acknowledged that the Visitor Centre would require significant repairs in the next few years following a survey of the building by NPS last November. The preferred option would be to secure funding to replace it with a new building, however this would be likely to be in the region of half a million pounds. Members did not wish to see the Legacy money being used for short term reacting repairs or refurbishment of the Visitors Center.
- Concerns were raised in respect to the proposals for new signage and branding in the park being damaged by anti social behaviour.
- Public consultation should be carried out in respect to the distribution of the legacy bequest by Frank Bramwell at Reddish Vale Country Park. Literature and posters should be advertised in the Visitors Centre, on the Stockport Council's website and the Reddish Vale Country Park website.

RESOLVED – That the report be noted and that Frank Bramwell's family be thanked for his bequest.

6. ENVIRONMENTAL AGENCY MEETINGS UPDATE

A representative of the Head of Area Governance reported that this item had been placed on the agenda at the request of Councillor Andrew Verdeille.

A representative of the Service Director (Communities) provided an update in respect to meetings which had taken place with the Environmental Agency. Discussions had taken place in late 2010 and funding applications had been submitted to the Environment Agency to improve the wetland area and also create disabled fishing pegs at the reservoirs. The outcome of these applications would be known later in the year and reported back to this Ward Committee.

RESOLVED – That the report be noted.

7. THE CONDITION OF THE VISITORS CENTRE, REDDISH VALE COUNTRY PARK

A representative of the Head of Area Governance reported that this item had been placed on the agenda at the request of Councillor Andrew Verdeille.

The Chair suggested that the item had been addressed during consideration of Agenda Item 5 – 'The Legacy Left by Mr Frank Bramwell to Stockport Council' earlier in the meeting.

On behalf of the Joint Ward Committee the Chair thanked Councillor Scott for his commitment and hard work during his tenure as a Reddish North Ward Councillor.

TAME VALLEY DEFENCE GROUP

Report on issues affecting users of Reddish Vale Country Park

In March 2008 the councillors decided that the number of issues affecting RVCP had developed into a Community Call for Action. It was decided to hold regular review meetings to tackle the various problems. Statement evidence was collated and sent to democratic services to be presented to the Tame Valley Councillors. TVDG drew the attention of the Parks Department to the following issues:-

Staffing,

Vandalism affecting biodiversity in Sunnyside Woods,

The pond habitat that was regarded as an absolute priority in 2005/6,

Access along Reddish Vale Road,

A growing state of irregularity concerning the control of fishing,

These were the priority issues.

Today, we have exactly the same problems:

We were told that the woodland would be fenced off to effect a restoration **two years ago**. This has not yet been done.

The plan for reinstating the nesting areas in the centre of the lower pond that **was planned in 2006** by Graham Pollard, who produced encouraging plans for this, has not yet been started and we have not seen any plans since then.

The tenants of Reddish Vale Farm have now built the bridleway across the field, but this has not changed the number of horses using the road or lessened the problems at all.

There is now **no one to act as bailiff** for the fishing ponds, which seems to have made a member of staff available for staffing other parks where an amenity that produces revenue is of paramount importance.

These issues are the salient issues. They are discussed at length in the document that was presented to committee along with statement evidence in 2008.

We accept that the Parks department have undertaken and carried out other work than that referred to here but three years ago these were the issues that were considered important by the active community. They still are.
