4. PRIORITIES AND RESOURCES 2011/12 - 2013/14

The Executive is proposing at its meeting on 26th October 2009 to request that Scrutiny Committees' comments are sought on Council priorities in the light of the future financial prospects facing the Council. - c) What other comments, if any, has the Committee got on the question of priorities and resources form 2011/12 onwards?
