4. CHANGES TO MENTAL HEALTH SERVICES

(Enclosed)

To consider a report of the Director of Operations and the Director of Nursing, Pennine Care NHS Trust.

The purpose of the report is for Members to be presented with the Service Development Strategy, proposed changes and their impact for Stockport. Contained within the proposals are plans for up to £13 million worth of efficiencies including the closure of 2 wards in Tameside and Stockport (Warren Ward).

This information should enable Members to come to a view on whether the proposals amount to substantial variation and as a result whether the Pennine Care NHS Trust should carry out statutory consultation and Stockport should be involved in making a response.

In doing this Members should take into account the reasons for the proposals, the impact they may have on patients/ the local area, the consultation proposed and the decision of the Joint Scrutiny Committee.

The Pennine Care Joint Scrutiny Committee, on which 3 Stockport Councillors are represented, has already been presented with the proposals and decided that they will not require a statutory consultation on the proposed changes. They have given general support to proposals whilst committing to continuing scrutiny of the changes at a Joint Committee level. The Joint Committee considered that the changes were concerning, but that the Committee were happy with these. The Joint Committee has agreed to regularly review the proposals and ensure that the commitments made to transfer services into the community come to fruition.
