4. ANNUAL HEALTHCHECK 2007/8 – TRUST DECLARATIONS

(Enclosed)

In 2005 the Healthcare Commission created a new approach to assessing and reporting on the performance of PCT and NHS Trusts. The annual health check replaced star ratings and requires NHS Trusts to produce a yearly self-assessment.

Under this approach all PCT and NHS Trusts are required to ask relevant health overview and scrutiny committees to comment on their performance against the 24 NHS core standards.

Overview and scrutiny committees are welcome to comment on any aspect of a PCT or NHS Trust performance against any of the core standard and their comments must be included in the Trust's declarations to the Healthcare Commission. The aim is to provide a "reality check" on the assessment and to demonstrate the links between services and the experience of local people.

There is no requirement for overview and scrutiny committees to comment as part of the health check and, as the Committee did not make provision in it's work programme to carry out specific activities to enable it to evidence comment on the Trust's declarations, it is accepted that the Committee may not be in a position to do so.

The attached reports present support information for both Stockport PCT 4 (i) and Stockport NHS Foundation Trust 4(ii).

The Committee is asked to consider the Trust's performance against the standards and agree whether or not the Committee is in a position to make evidenced comment on any aspect of this performance.
