8. JOINT COMMISSIONING OF OLDER PEOPLE'S HEALTH AND SOCIAL SERVICES SCRUTINY REVIEW (Enclosed)

To consider a report of the Assistant Chief executive(Strategy, Performance and Governance)

This is the final report of the Scrutiny Panel carrying out the review of older people's social care and health services.

This review has been carried out at the same time as Stockport Primary Care Trust (PCT) has led a review of non-acute services for older people. This has been a major piece of work which has led to proposals for a new model of delivery which increases the level of care provided in the community, and replaces services currently provided from three wards at Cherry Tree Hospital.

The Panel recognised that the timing of the review created an additional demand on workload across the Council, PCT and Foundation Trust. Accordingly, the work of the Panel took the form of evidence-gathering about the existing structures and rationales for commissioning of older people's health and social care services, rather than a comprehensive attempt to redesign the whole system.

This report addresses the following topics:

- Demographic changes and increased pressures upon social care and health systems.
- National policy context.
- Joint commissioning of older people's social care and health services in Stockport.
- Stockport PCT's proposals for Developing and Improving Non-Acute Services for Older People.
- Future challenges for joint commissioning.
- Conclusions made by the Panel.
