#### **Annual Health Check & Standards for Better Health 2007-8**

#### **INTRODUCTION**

The first half of this paper looks at the overall process for the Annual Health Check, the second half will look specifically at the Trust's Standards for Better Health Self declaration for 2007-8.

#### **ANNUAL HEALTH CHECK**

The Healthcare Commission continues to award NHS trusts a rating that consists of two elements: quality of services and use of resources. Stockport NHS Foundation Trust's performance for the years 2005-6 & 2006-7 gave the trust a "good" rating for Quality of Services and an "excellent" rating for the use of resources.

As in 2006/2007, the quality of services element will be derived from our assessment of performance on the Standards for Better Health and on existing & new national targets. The use of resources element is derived from assessments carried out by Monitor .

Core	All trusts will be required to make a declaration of compliance with the core standards.  All trusts will be required to submit a statement of compliance regarding the hygiene code covering the whole assessment year.	The criteria that we publish will be rationalised and, where possible, reduced.  Trusts will not be required to make a declaration of their progress against developmental standards.  We will issue a small set of benchmark indicators to trusts to show their position relative to similar trusts in the domains of safety, quality and public health. We expect that trust boards will use this information and local data when reviewing their performance and considering their compliance with the core standards.  The indicators will be derived from existing national data and from the information in the toolkits that we issued to trusts as part of the shadow assessment of developmental standards for 2006/2007. We will focus on those indicators that trusts have told us they have found most useful and that provide information on the outcomes required by the three domains. Trusts will also be invited to comment on these indicators.  We will incorporate new statutory requirements relating to ionising radiation in the criteria for assessing performance in relation to safety.

We will consult on any changes to this assessment with Monitor and the Audit Commission.		

#### **STANDARDS FOR BETTER HEALTH**

As in previous years the Core Standards for Better Health are assessed through a self declaration process and are also potentially followed up by Healthcare Commission visits in 20% of trusts. The purpose of these visits are to ratify information and data, some visits are risk based and others are random.

The declaration needs to be completed and returned to the Healthcare Commission by midday on the  $30^{th}$  April 2008 and the declaration should cover the period  $1^{st}$  April  $2007 - 31^{st}$  March 2008.

The Healthcare Commission recommends that healthcare organisations need to consider all of the elements that refer to the services they provide. The Healthcare Commission expect healthcare organisations to consider **all** aspects of their services when judging whether they have *reasonable* assurance that they are meeting the published elements.

The trust examines these standards through the appropriate executive leads for each of these standards who will this year sign off a compliance status against these standards. As well as this, the

Standards for Better Health and their assurances are presented and discussed through the Assurance Risk Committee ( 10<sup>th</sup> March & 14<sup>th</sup> April 2008.) As with last year, this needs to be signed off by the Board of Directors and opportunities given for comments from Governors, the Stockport Council Health Scrutiny Committee as well as the Patient & Public Involvement in Health Group for Stockport NHS Foundation Trust. Stockport Council Health Scrutiny Committee are discussing the declaration and their commentary at their next meeting on the 1<sup>st</sup> April 2008 and the commentary from the Patient & Public Involvement in Health Group for Stockport NHS Foundation Trust has already been received and can be seen in Appendix 1.

The Standards for Better Health are divided into 7 "domains" and cover 24 standards for healthcare, most of these standards are broken down into further elements. An overview of the areas covered can be seen in Appendix 2.

The timetable for the declaration process an be seen in Appendix 3.

As can be seen the assessment process is still ongoing, however the tentative position currently is that the Trust will be compliant against all of the Standards for Better Health. As a Trust we would welcome a commentary from the Stockport Council Health Scrutiny Committee regarding the Annual Health Check Self assessment process.

# Patient and Public Involvement in Health

## Stockport NHS Foundation Trust Patient and Public Involvement in Health Forum Healthcare Commission Annual Health Check Commentary, February 2008

The Stockport NHS Foundation Trust Patient & Public Involvement in Health (PPIH) Forum worked closely with the Trust to carryout visits/inspections and monitor services from the perspective of patients. The Forum responded to public concern, expressed by members of the community and in the media, on the Trust's services and made recommendations where appropriate.

Core Standards	Forum comments
C17	Hospital Discharge The Forum has worked with the Trust to develop ways to improve the experience of patients and their carers upon being discharged from Stepping Hill Hospital. The Forum was this year invited to join the 'Discharging Patients from Hospital Group' and has contributed to a body of work to improve standards. The Forum now feels pleased with the improvements that have been made in the last 12 months by the Trust and endorses the set of standards now in place to ensure better patient care upon discharge.
C17	Older People's Rehabilitative Care (Development of Non-Acute Services)  The Forum raised its concern of the negative ramifications of community-based services not being in place prior to the closure of Cherry Tree Hospital, from where respite services for older people are delivered. A Forum representative obtained an agreement via the Overview & Scrutiny Committee (OSC) and Stockport PCT's Clinical Governance Meeting that respite services would only cease once community-based services were in place. This has resulted in the closure of the hospital being delayed and in December 2007, the Stockport PCT Board announced that the intended plan could not be signed off due to the changes that had to be made. These changes resulted from this work.
C14 C18	Choose & Book The Forum has continued to monitor the development of Choose & Book and gathered information & anecdotal evidence to feed this patient perspective back to the Trust. Stockport PCT is to include the Forum's suggestions in the development of the service.
C19	Stroke Services The Forum conducted a joint visit with Stockport PCT PPIH Forum to the Stroke Unit at Stepping Hill Hospital to familiarise themselves with existing services and speak with clinicians regarding the proposed changes. A Forum member was



C4	Infection Control Follow-Up Visits The Forum has continued to conduct official visits regarding infection control, as a follow-up to its work on the Bugwatch campaign and to monitor cleanliness and hygiene standards within Stepping Hill Hospital.
