3. MINUTES

The minutes (copies of which had been circulated) of the meeting held on 15 March 2005 were approved as a correct record.

4. DECLARATIONS OF INTEREST

No declarations were made.

5. DFES CONSULTATION ON THE DRAFT SCHOOL ADMISSIONS CODE

A representative of the Corporate Director, Children & Young People submitted a report (copies of which had been circulated) detailing the main proposals, guidelines and requirements contained within the proposed code

RESOLVED – That the report be noted.

6. ADMISSION ARRANGEMENTS AT MAINTAINED SCHOOLS 2008/2009 AND SCHOOL TERMS AND HOLIDAY DATES 2008/2009 - CONSULTATION

A representative of the Corporate Director, Children & Young People submitted a report (copies of which had been circulated) detailing proposals to make significant changes to the Authority's School Admissions Policy and Procedures and outlining proposed school terms and holiday dates for the academic year 2008/2009.

The following comments were made/issues raised:-

- As a result of significant changes to the Code of Practice on school admissions the authority could no longer provide a priority area guarantee.
- There was a significant minority of parents who assume that a place at a secondary school was guaranteed as a result of having their children attend an associated primary school.
- There was a need to ensure that the admissions criteria are relayed to parents as
 effectively as possible to dispel any misconceptions.
- The role of priority areas in ensuring that local children attended local schools was one which was valued.
- The disadvantage of using straight line distance as a criteria for school admissions
 was that those schools on the periphery of the Borough could subsequently draw the
 majority of their pupils from outside the Borough.
- There was a need to ensure that school holidays were as far as possible coterminous with those of neighbouring authorities to ensure that family life was not disrupted in those families where children or parents attended or worked at schools in different authorities.
- Cheshire and Derbyshire County Councils should be consulted in addition to other Greater Manchester authorities in the setting of school terms and holidays dates for Stockport 2008/2009.

RESOLVED - (1) That the report be noted.

(2) That the Corporate Director, Children & Young People be requested to consider the comments of this Forum in the setting of school terms and holiday dates for 2008/2009.

7. ADMISSIONS TO PRIMARY AND SECONDARY SCHOOLS 2005/2006

A representative of the Corporate Director, Children & Young People submitted a joint report of the Corporate Director, Children & Young People and the Chief Executive (copies of which had been circulated) outlining the allocation of places to maintained primary and secondary schools in September 2006 and the pattern of admissions to secondary schools after the normal admissions round during 2005/2006 including the work of the Educations Appeals Panel over the last twelve months.

8. SCHOOL ADMISSION ARRANGEMENTS FOR VULNERABLE PUPILS 2005/2006

A representative of the Corporate Director, Children & Young People submitted a report (copies of which had been circulated) detailing the Authority's arrangements for the admission of vulnerable pupils to the Pendlebury Centre and the Secondary Behaviour

Support Service Pupil Referral Units in the 2005/2006 academic year. The report also details the Authority's arrangements for the reintegration and education of permanently excluded pupils and the managed transfer of pupils at risk to exclusion during the 2005/2006 academic year.
