Edgeley Fold - Bollards

Report of the Corporate Director for Place Management & Regeneration

1.1 To seek approval for the introduction of 9 Bollards on the footway of Edgeley Road in the vicinity of Edgeley Fold controlled pedestrian crossing and outside the Orthodontists. To also seek approval to close the gap between the access protection markings (APM) outside numbers 42 and 44 Edgeley Road as the small gap left is not adequate for a car to park.

1. BACKGROUND

2.1 Over the last few year SMBC have received several reports in regard to vehicles using the controlled pedestrian dropped crossing point to gain access to the footway to park outside the Orthodontists. This overrunning the footway and parking manoeuvre is a danger to pedestrians, and this is not an authorised access point for vehicles. Together with the closure of the gap in the APM situated outside numbers 42 and 44 Edgeley Road, this will help to prevent parking just before the controlled pedestrian crossing and aid visibility for both drivers and pedestrians, as well as prevent being ticketed as cars would overhang the markings.

2. PROPOSALS

- 2.1. To introduce 9 bollard type posts around the vicinity of the crossing point and in front of the Orthodontists on Edgeley Road, as shown on **Drawing No. NM1-6342-00**, which will help to prevent this illegal use of the footway and the extension of the APM to close the gap between the two to prevent parking before the controlled pedestrian crossing.
- 2.2. Consultation is not required due to the type of works, but a letter drop will be carried out informing residents these works will be undertaken prior to installation
- 2.3. The Council has a duty of care for the general public and to ensure the highway remains safe. Thus, the installation of the bollards will help to protect pedestrians from vehicles manoeuvring on the footpath and the APM will also aid road safety.

3. FINANCIAL IMPLICATIONS

3.1. The estimated cost of the scheme is as follows:

Installation of 9 bollard type posts & Extension of APM & associated works £4468.19

TOTAL £4468.19

To be funded from the Edgeley Ward Budget.
