Range Road	Residents parking scheme reviewed due to maintenance. Objection report deferred at the meeting of the Area Committee held on 10 August 2017 for reconsideration.
Crosby Street (Well Grove – Adswold Lane East)	Awaiting decision on Davenport and Cale Green Permit Parking Zone (below) before proceeding.
Wellington Grove	Awaiting decision on Davenport and Cale Green Permit Parking Zone (below) before proceeding.
Davenport and Cale Green Permit Parking Zone	Proposed Permit Parking Zone. Drop in meeting arranged for 31 October 2018. Awaiting details re businesses. Consultation documents sent out in June. Sent to Legal for advertising. Legal Notices to be placed out from 22/01/2020 for 3 weeks. Objections considered by the Area Committee on 23 July 2020 and the Cabinet Member for Sustainable Stockport subsequently agreed that the Orders be made as originally advertised.
Lowfield Road	Petition for one-way. Historical reasons for removing one way 20-30 years ago and wider impact on HGVs on Range Road etc. Draft plans sent to Councillors. To be discussed with managers in Winter 2019/2020 to see if scheme to be progressed or no further action.
East Street	Proposed waiting restrictions. Consultation to be prepared July 2019. Comments received from Stockport Homes to be considered.
Voewood House	Rationalise existing restrictions. Site visits done to check existing markings and signs September/October. Traffic Regulation Orders to be rationalised – plans to be drawn up May-August.
Toronto Road	Proposed Waiting Restrictions. Consultation documents to be prepared August/September 2019. Report submitted to the last meeting of the Area Committee. Legal notice onsite. The advertising process resulted in a substantial number of formal objections. Agreed with Councillors to re-consult on revised proposal with reduced lines. Report on the amended scheme approved by the Area Committee in November 2020. Traffic Regulation Order to be advertised in due course.

Charles Street	Proposed Waiting Restrictions. Currently out to consultation until 20 September 2019. Consultation results sent to Councillors on 23rd October 2019. Highway Ward Spokesperson requested a Committee report. Swept path vehicle tracking plans drawn up prior to report being prepared for Area Committee. Report approved March 2020. Traffic Regulation Order advertised and objection received. Anomaly was identified with the legal order as advertised. Report to be submitted to the Area Committee to consolidate the scheme.
Hempshaw Lane – Battersby Hat Works site	Traffic Regulation Orders as part of the redevelopment. Report submitted to the March meeting of the Area Committee. Traffic Regulation Order to be advertised in due course in agreement with Development Control.
