Report of the Corporate Director for Place Management & Regeneration

1. INTRODUCTION AND PURPOSE OF REPORT

1.1. Members are requested to consider the contents of the report and approve the proposed traffic regulation orders.

2. BACKGROUND

2.1. In January 2019 the Central Area Committee approved the implementation of the Mayor's Cycling and Walking Challenge Fund scheme for a new route between Offerton and Stockport. One of the proposals within the Offerton to Stockport scheme provides a new toucan crossing on Offerton Lane, close to the junction of Salcombe Road and a short section of shared footway/cycleway on Salcombe Road. The scheme is now nearing completion, however, officers have been made aware of an issue with regards to vehicles parking within the narrowed section of Salcombe Road.

3. PROPOSALS

- 3.1. The previously approved scheme included a 'No Waiting at Any Time' (NWAAT) order at the junction of Offerton Lane/Salcombe Road that extended along Salcombe Road in a north easterly direction for a distance of 10m. This does not cover the full length of the narrowed section of Salcombe Road and, since the schemes completion, officers have received reports that vehicles parked within the narrowed section are creating a potential hazard for vehicles exiting Salcombe Road. Motorists attempting to exit Salcombe Road when travelling south west bound are positioned into the path of oncoming north east bound vehicles due to the parked vehicles.
- 3.2. It is therefore proposed to extend the NWAAT order to the full extent of the narrowed section of Salcombe Road, see plan Ref C/0280A/1200/003 in Appendix A.

4. LEGAL POSITION/IMPLICATIONS

4.1. The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

5. FINANCIAL IMPLICATIONS

5.1. The proposal will be funded from the MCF Capital fund.

6. CONCLUSIONS AND RECOMMENDATIONS

6.1. No Waiting at Any Time

Salcombe Road (Both sides) – From a point 10m north east of the intersection of the north eastern kerbline of Offerton Lane for a distance of 21 metres in a north easterly direction.
