**Report of the Corporate Director for Place Management & Regeneration**

**1. INTRODUCTION AND PURPOSE OF REPORT**

To approve the relocation of two speed humps on Blackstone Road in Offerton as part of a new housing development.

**2. BACKGROUND**

Members will be aware of the Blackstone Fields residential housing development in Offerton. As part of the new build, it has been deemed necessary to relocate two speed humps on this part of Blackstone Road to accommodate the proposed access road. The associated costs (Inc. legal advertising) for the relocations will be funded by the housing developer as part of the planning conditions.

**3. PROPOSALS**

**4. LEGAL POSITION/IMPLICATIONS**

- 4.1. The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.
