After what has been a difficult 18 months for everyone, theatres are finally beginning to re-open and many amateur societies are working with their members to bring back a vital and underfunded art form back to the centres of local communities.

In 2020, The East Cheshire's were a few weeks away from staging their production of 'Chicago' at Romiley Forum when the pandemic first struck. Rehearsals had been running for a number of months and the 40 strong cast were excited about the opportunity to bring such an iconic production to the local community. The cast and society members were devastated when the theatres were closed and our production was halted.

Over a year later, the society are now working hard to bring a production of 'Sister Act' to the Romiley Forum. We are extremely lucky to have secured the rights to a restricted show at a very important time when members and audiences will benefit from re-igniting their passions and hobbies by engaging in local theatre. In order to stage a production of this calibre however, we are looking for funding to support us through the move to a new theatre space, set and costume costs, and the ever-increasing costs associated with theatre.

Rehearsals will take place at Bradshaw Hall Primary School, Cheadle and the production will take place at Romiley Forum, Romiley.

A production such as 'Sister Act' requires a great financial outlay - the set hire alone will run to the thousands, given the 23 different scene changes. There are approximately 132 costumes needed for a cast of 35 and many of these will need to be hired from professional costumiers due to the intricacy and complexity of the designs and 1970s period setting. Furthermore, we are a society that is committed to supporting all elements of the arts, which is why the show will be supported by a live 12 piece band, again with costs associated with paying the band members, the hire of specialist sound equipment and the costs of paying a sound and lighting engineer. Amateur theatre brings great joy to the members and patrons on stage and is always hugely popular with communities and supporting audiences, but each year the costs increase and staging 'Sister Act' will run to approximately £20k.

Funding will not only help with the burden of these costs, but will allow us to widen our promotional material for both members and for the audience. Staging this fantastic and incredible work in the East Cheshire area is an exciting opportunity and will no doubt bring new members and talent to the stage. We are confident that this project will allow us to expand in the community and draw theatre goers from across the Greater Manchester area.

A grant of £1000 will go a long way to help us stage this incredible musical in 2021. The current committee of the East Cheshire's are determined to continue the legacy of a historic theatre company; it is through the generosity of grants that we will be able to do this.
