# 1. INTRODUCTION AND PURPOSE OF REPORT

To approve No Waiting at Any time restrictions on part of Newby Road and address an anomaly with existing restrictions.

### 2. BACKGROUND

Network Management received representation via a local Ward Councillor concerning that part of Newby Road between the junctions at Bramhall Moor Lane and Arnside Avenue.

It was reported that vehicles parking along that side which is currently unrestricted are causing conflict amid on-coming traffic (Inc. heavy freight) to and from the Ind. Estate with related concerns over visibility and road safety for occupants exiting their properties.

As part of the investigation, it also came to light that the stretch of double yellow lines on the opposite side of this part of Newby Road are not supported with a Traffic Regulation Order. Hence this report will provide opportunity to formalise the restrictions.

### 3. PROPOSALS

A proposal was drafted to extend the existing double yellow lines (No Waiting at Any Time) along the north easterly side so that the full extent between the said junctions is restricted. Please see attached drawing number: **NM8-4214-001**.

# 4. LEGAL POSITION/IMPLICATIONS

The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

# 5. CONSULTATION

A local consultation with the immediate households and nearest business premises did not result in any opposition to the proposed scheme.

# **Newby Road**

North Easterly side from a point 10 metres North West of the North Westerly kerb line of Arnside Avenue for a distance of 51 metres in a North Westerly direction and to tie-in with existing.

South Westerly side from a point 15 metres South East of the (projected) South Easterly kerb line of Arnside Avenue in a North Westerly direction for a distance of 79 metres and to tie-in with existing.
