The consultation received 483 responses. Of those who responded 121 (25%) supported the trial proposals whilst 362 (75%) objected. <u>Cheadle and Cheadle Heath Active Neighbourhood – Results of Trial</u> <u>Consultation</u>

Report of the Corporate Director for Place Management & Regeneration

1. INTRODUCTION AND PURPOSE OF REPORT

- 1.1 In October 2020 Transport for Greater Manchester (TfGM) successfully bid for funding from the Mayor's Challenge Fund to develop ten Active Neighbourhoods across Greater Manchester; one in each district. In Stockport the area selected for the Active Neighbourhood was Cheadle and Cheadle Heath.
- 1.2 TfGM commissioned Arup as lead consultant working with Sustrans and 10GM to develop the project using a community co-design approach with the aim of involving residents, businesses and other stakeholders in the task of identifying issues and providing ideas for solutions to the problems identified.

February 2021

- 1.3 The project was launched by Arup/Sustrans in February 2021 with the following stakeholder engagement activities:
 - 3,695 leaflets sent to all households within and just beyond the project area to invite them to 'co-design' a potential scheme
 - Individual emails and phone calls to relevant local groups in the area
 - A 'Tell us about your street survey'
 - An interactive online map was set up to allow residents to leave comments on what they liked disliked or would improve in their area.
- 1.4 As a result of these engagement activities:
 - 258 people signed up to receive updates about the project
 - There were 383 responses to the "Tell is about your street" survey and 56% stated that there's too much traffic on their street.
 - 44 people left 254 comments about their area on the interactive online map.

April 2021 to July 2021

- 1.5 Three online workshops were then undertaken between April and July 2021 to which local people and key stakeholders were invited. The objective of the first two workshops was to understand local views regarding the issues within the area and the objective of the third was to co-design draft interventions that then directly informed the trial plan. These could not be held in person due to Covid-19 restrictions.
- 1.6 The workshops were advertised on the project webpage and by email to stakeholders and those signed up to receive updates. 150 posters were

also put up in the local area at the beginning of July 2021 to advertise the third workshop. The workshops were attended by 88 people in total.

August 2021

- 1.7 3,695 leaflets sent to all residences to provide information regarding the proposed plans for a temporary trial scheme and to ask for feedback.
- 1.8 This report details the results of the August 2021 consultation.

2. INFORMATION

- 2.1. A public consultation exercise regarding the proposed trial was undertaken with all stakeholders and residents within the Active Neighbourhood boundary between Friday 6th August and Friday 20th August 2021. The consultation comprised a leaflet drop to 3,695 properties. The leaflet comprised a summary of the trial proposals and a plan showing the locations of the proposed point road closures. A copy of the leaflet and the plan showing the scheme proposals, as consulted upon, are included in Appendix A.
- 2.2. A summary of the responses to the consultation are provided in the next section.

3. CONSULTATION RESULTS

- 3.1. The public consultation exercise invited members of the public to provide feedback via email to the active.cheadle@stockport.gov.uk address or telephone. In total we received 483 responses, a 13% response rate.
- 3.2. Of the 483 that responded 121 (25%) supported the trial proposals whilst 362 (75%) objected.
- 3.3. Those that responded gave the following concerns/issues as their reasons for objecting. These are ranked by volume of comments made:

- 3.4. 35 of the responses received that objected to the proposed trial were generated by the 'Resident's Against Active Cheadle proposals' action group who devised the generic text for their members to copy, paste and email in.
- 3.5. Officers were also made aware that a petition had been generated however this has not been received to date.
- 3.6. Some of those that responded also made requests for alternative measures to be installed. These are summarised below:

3.7. As a result of the feedback received regarding the proposed trial it is recommended that a trial of the current proposals does not take place in October 2021 as planned.
