### **1. MINUTES**

The Minutes (copies of which had been circulated) of the meeting held on 16 June 2021 were approved as a correct record.

### **3. CALL-IN**

There were no call-in items to consider.

### **4. YOUTH JUSTICE PLAN 2021/22**

The Director of children's Services submitted a report (copies of which had been circulated) providing a statutory annual plan that is required under Section 40 of the Crime and Disorder Act 1998 which sets out the Youth Offending Partnership's responsibilities in producing this plan and states that it is the duty of each local authority, after consultation with the partner agencies, to formulate and implement an annual youth justice plan.

The Cabinet Member for Children, Family Services & Education (Councillor Colin Foster) attended the meeting to respond to questions from the Scrutiny Committee.

The following comments were made/issues raised:-

- It was commented that the report made reference to the knife crime awareness strategy programme "On the Edge" and at Tier One, the involvement of 5 and 6 year

olds. In response, it was stated that it was not 5 and 6 year olds, but the current Years 5 and 6.

- Clarification was sought relating to ongoing training programmes and supporting the young people. In response, it was noted that the team worked closely with “Mosaic” which involved interventions and screening done both by the team and “Mosaic”.
- It was noted that the restorative justice was working well and the team were encouraged to keep up the good work.
- It was commented that during the pandemic there were a number of different types of behaviours from young people e.g. anti-social behaviour and off road bike riding which resulted in additional funding to develop the youth work programme. It was also stated that Detached Youth Workers were back on the street following the funding to respond to these behaviours.

The Committee recognised the detail in the report and thanked Jacqui Belfield-Smith and her team for such a well written report.

RESOLVED – That the report be noted.

## **5. PREJUDICE BASE BEHAVIOURS AND RELATIONAL BULLYING**

The Director of Education submitted a report (copies of which had been circulated) providing an outline to the proposed scope and brief with regard to dealing with prejudice-based incidents/ bullying type behaviours.

The Cabinet Member for Children, Family Services & Education (Councillor Colin Foster) attended the meeting to respond to questions from the Scrutiny Committee.

The following comments were made/issues raised: -

- It was commented that it was good to hear about the data being collected, but the figures were a bit out of date and were not a true reflection of the current picture of the borough.
- Clarification was sought regarding the number of schools that had taken part in providing the information and were the schools evenly spread in terms of the secondary and primary schools and was the information selective and consistent across the borough. In response it was stated that the information was not available, but would be collated and shared with the Committee in due course.

RESOLVED – (1) That the report be noted.

(2) That the following information be shared with the Committee relating to:

- the number of schools (secondary and primary) involved in providing the data;
- a breakdown of the schools involved across the borough; and
- was the information selective and consistent across the borough.

## **6. SCRUTINY REVIEW TOPIC SELECTION**

A representative of the Strategic Head of Service & Monitoring Officer (Legal & Democratic Governance) invited the Scrutiny Committee to choose a Scrutiny Review topic for inclusion in the 2021/22 scrutiny work programme.

RESOLVED – (1) That the Council Meeting be recommended to include:-

- Strategy for School Places – Pupil Place Planning in the Borough within the 2021/22 Scrutiny Work Programme; and
- Sexism and Misogyny in Stockport Schools (to include racism and bullying) within the 2021/22 Scrutiny Work Programme.

## **7. AGENDA PLANNING**

A representative of the Strategic Head of Service & Monitoring Officer (Legal & Democratic Governance) submitted a report (copies of which had been circulated) setting out the planned agenda items for the Scrutiny Committee's next meeting and any Forward Plan items.

Councillor Senior proposed that the Director of Education (Tim Bowman) provides the Committee with a review on his working experiences to date including what has worked well and where there maybe areas for improvements.

The Chair suggested that an update be submitted to the Committee on pupils transitioning from primary to secondary school during the pandemic, identifying any issues and where improvements could be made.

RESOLVED – (1) That the report be noted.

(2) That the Strategic Head of Service & Monitoring Officer (Legal & Democratic Governance) be recommended to programme the following items into the Scrutiny Committee's work programme for the 2021/22 Municipal Year:-

- A review from the Director of Education relating to his work experiences to date including what has worked well and the areas for improvement.
- An update on the pupil transitions from primary to secondary school during the pandemic, identifying any issues that occurred and where improvements could be made.
