### 1. INTRODUCTION AND PURPOSE OF REPORT

1.1 To Consider an objection to a proposed Traffic Regulation Order at Woodville Grove and Newark Road Reddish.

## 2. BACKGROUND

2.1. The Corporate Director in agreement with the Ward Spokesperson at the time consulted on proposed restrictions (No Waiting at Any Time) in the head of the culde-sac on Woodville Grove to assist vehicles with turning movements. The consultation resulted in some adverse responses from occupants who live on this part of Woodville Grove and (by way of a compromise) the extent of the proposed restrictions was reduced and a revised scheme (see attached drawing number: NM8-5145-001A) was duly approved by the Area Committee

# 3. OBJECTION

3.1 The legal advertising process has resulted in a formal objection from a resident who feels that the original extent of the restrictions should not have been reduced and the revised scheme is not adequate.

# 4. LEGAL POSITION/IMPLICATIONS

4.1. The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

# 5. IN RESPONSE THE CORPORATE DIRECTOR WOULD COMMENT AS FOLLOWS:

5.1 Obviously there is no perfect solution where residents and road users have conflicting interests. It is appreciated that the revised scheme is a compromise between these interests and it will at least provide some space for vehicles to do a turn-around manoeuvre.
