Covent Garden Village	Traffic Regulation Orders for new housing development. Experimental TRO advertised February 2021 to March 2021.
Chelmsford/Chatham Street	Traffic Regulation Orders No Waiting At Any Time junction protection. Consult with residents/businesses September 2021. Consultation results to be analysed.
Kenilworth Road	Automated Traffic counter request. Survey completed.
Avondale Road	Traffic Regulation Order No Waiting At Any Time on industrial estate to the right hand side only. Consult with residents/businesses September 2021. Consultation results to be analysed.
Sandown Road/Stockport Road	Traffic Regulation Order No Waiting At Any Time at Stockport Road junction with Sandown Road. Consult with residents/businesses September 2021. Consultation results to be analysed.
Toronto Road	Proposed Waiting Restrictions. Report on amended scheme approved at the Area Committee in November 2020. Traffic Regulation Order to be advertised on site.
Mercian Way/Bergara Close	Traffic Regulation Order for new housing development and resident parking zone. Approved at the meeting of the meeting of the Area Committee in April 2021 and Traffic Regulation Order advertised in August 2021. Traffic Services to send out permit letters to residents. Signs on site awaiting surfacing of carriageway by developer.
Charles Street	Proposed Waiting Restrictions. Traffic Regulation Order advertised 21 September 2020. Objection received and an anomaly was identified with the legal order as advertised. Report submitted to this meeting of the Area Committee.
Hempshaw Lane –	Traffic Regulation Order as part of the redevelopment. Report approved March 2020. Traffic Regulation Order

Battersby Hat Works Site	advertised with no objections.
York Street	Signage for No Through Road. Draft up sign and post location to enable quote for works. To be installed October 2021.
Heavily Grove	Parking issues on private road and car park. Reviewed on site on more than three occasions. Reviewed on different days and different times. Images taken on site. No issues noted so far.
Firwood Close	Parking and viability issues on Firwood Close due to Health Centre Car Park. Site visit completed. Drawings created for three different options. Further request for Give Way markings have been investigated and confirmed not possible. New request now for Keep Clear Markings. Consultation undertaken on waiting restrictions.
Brinnington Estate	General maintenance and signage issues around whole of estate. Initial site visit undertaken. Repairs to be undertaken and road markings require refreshing.
Brinnington Estate	General speeding issues around the whole of the estate. Reviewed areas where there is perceived speeding and which areas are currently a 20mph zone within the area. Look to review area as future active neighbourhood scheme.
Kimberley Street	Specific automated traffic counter requested for this road due to speeding issues. Cobbled street so not possible to install automated traffic counter without damage to surfacing. Other options to be explored.
Lapwing Lane	Specific automated traffic counter (ATC) requested for this road due to speeding issues. ATC ordered October 2021.
Countryside Estate – Blackberry Point	Specific automated traffic counter requested for this road due to speeding issues. ATC ordered October 2021.
Forbes Road and Forbes Close	Parking restrictions at the junction. Report approved August 2021. Advertised 27 September 2021.
East Street	Proposed Waiting Restrictions. Comments from Stockport Homes being considered
Voewood House	Rationalise existing traffic restrictions
Lowfield Road	Petition for one-way

Bexhill/Douglas Road	Investigate possible traffic calming measures
Harrison Grove	Check weight restriction signage improvements at western end/Europa Way
Bramhall Lane	Additional pedestrian crossing investigation
