Mission Christmas is the largest children's Christmas gift appeal in the UK and the local team in Greater Manchester were able to help a total of 30,697 children last year, with over 2100 children from the borough of Stockport.

A third of the youth population are going to bed without a hot dinner, living with no central heating, and don't have a sufficient school uniform. For these families, Christmas is simply a luxury they can't afford. You will be aware that the government have just reduced Universal Credit, fuel prices are rocketing pushing many families into fuel poverty; Cost of living is increasing while income is decreasing. Many of the families we work with are working families and with furlough ending, more redundancies will be inevitable. Many of the parents we help are literally choosing between putting food on the table and heating their homes.

Our Mission is to ensure that EVERY child and teenager wakes up to a visit from Santa on Christmas morning, but he needs our help! Its more than just a gift, it's about knowing someone cares and making Christmas Day different.

Every year we appeal to our supporters to donate an extra gift or make a cash donation to enable us to bring the magic of Christmas to children who would otherwise go without. Throughout November and December we are based in a warehouse in Hazel Grove where we rely on volunteers to help us achieve our mission. Children are identified by social services, teachers, Greater Manchester Police, and other charitable organisations, and we fulfil as many applications as possible depending on the donation levels. Each child is gifted approximately £40 worth of gifts. The number of children we help depends solely on the levels of support we are able to rally. Cash donations allow us to purchase gifts from the relationships we have with wholesalers, allowing us to help more children.

£40 will help one child. There are 14,531 Children living in poverty in Stockport (25.4%) (Source: End child Poverty 2019/20) and we want to help as many of these as possible.

10(b) Are there any restrictions on who will benefit from the funding?

We do not accept applications directly from families themselves, in order to ensure we are reaching the most needy we work with social services, schools, GMP etc, so all referrals must come through an official channel. When we receive personal referrals, we do our best to help them to find an authorised person to support their application.

Each year completely varies, it is entirely dependant on the support we receive. I can assure that the costs of the project will never exceed 20% of the results.

One thing we're especially proud of is our contribution rate-in the UK, when you give a pound to charity, on average, 56 pence of it goes to the cause with 44 pence covering running costs. Of course there is a cost to fundraising but at Cash for Kids we guarantee that a minimum of 80 pence in every pound goes directly to the help the children that need it most. Our most recent figures for 2020 show that this was actually 89p last year! We're really lean teams and work as hard as we can to ensure donations from our supporters are making the biggest difference possible.
