<b>Summary:</b> To seek approval for the supply & installation of 14 No. Timber Posts; 6 No. to be installed on Bramhall Park Road and 8 No. to be installed on Linney Road. The installation of the timber posts will act as a preventative measure to prevent vehicles from parking on and damaging the grass verges.

### Bramhall Park Road & Linney Road, Bramhall - Timber Posts

Report of the Corporate Director for Place Management & Regeneration

### 1. INTRODUCTION AND PURPOSE OF REPORT

- 1.1 To seek approval to erect 6 No. wooden posts along the edge of grassed verge located on Bramhall Park Road.
- 1.2 To seek approval to erect 8 No. wooden posts along the edge of the grassed verge located on Linney Road.

### 2. BACKGROUND

- 2.1. Timber posts have been previously installed on a substantial area of the grassed verges along Bramhall Park Road however, a small area was missed, and vehicles are now reported to be parking on this same area and causing damage to the grass.
- 2.2. Vehicles are reportedly parking on one of the grassed verges located on Linney Road and in doing so, are causing damage to the grass. Residents are requesting timber posts on Linney Road to prevent this damage.
- 2.3. A Traffic Services Officer met with the Local Highway Ward Spokesperson and the resident on site at which time, the Highway Ward Spokesperson agreed to fund 50% of the costs in relation to the Linney Road element, with the resident to fund 50%.
- 2.4. Although verge protection methods such as posts can prevent a driven lawn mower from cutting the verge, strimmers can be used instead. However, as strimmers are a more time consuming and costly way of grass cutting, posts and signs are only installed where there is a persistent parking problem and grass around posts may not be cut regularly.

### 3. PROPOSALS

- 3.1. In order to prevent vehicles from mounting the grassed verge on Bramhall Park Road it is proposed to install 6 no. wooden posts along the edge of the verge as shown on **Drawing No. NM1-Bramhall Park Road-01.**
- 3.2. In order to prevent vehicles from mounting the grassed verge it is proposed to install 8 no. wooden posts along the edge of the verge as shown on **Drawing No. NM1-Linney Road-01.**

### 4. LEGAL POSITION/IMPLICATIONS

### 5. CONSIDERATION OF ALTERNATIVE SOLUTIONS

5.1. No other alternatives were considered.

### 6. CONSULTATION

6.1. It is not necessary to carry out a consultation for the installation of these wooden posts.

### 7. FINANCIAL IMPLICATIONS

- 7.1. Full cost to the Delegated Ward Budget will be £1,525.00. Breakdown is as follows:
  - **Bramhall Park Road:** The costs for the supply & installation of the timber posts is £920.00, to be funded wholly by the Delegated Ward Budget.
  - **Linney Road:** The costs for the supply & installation of the timber posts is £1,200. Of which, £605.00 is to be funded by the Delegated Ward Budget and £605.00 is to be paid for by the resident.

### 8. TIMESCALES

- 8.1. Totally Local Company have advised that there is currently a 10 week 'lead in time' on all works relating to the installation of timber posts: Timescales for completion are as follows:
  - Bramhall Park Road: January-February 2022.
  - **Linney Road:** works will not be ordered until payment of £605.00 has been received from the resident. Assuming the resident makes payment immediately, we would expect a completion date of January-February 2022.

The installation of the timber posts will act as a preventative measure to prevent vehicles from parking on and damaging the grass verges
