Report of the Corporate Director for Place Management & Regeneration

1. INTRODUCTION AND PURPOSE OF REPORT

To approve measures related to road safety around Stockport School and approve the allocated costs as described. Note: Mile End Lane which is adjacent to the School straddles the boundary between Stepping Hill and Central Area Committees.

2. BACKGROUND

In September 2021 at the behest of the School, a site meeting was organised with Council Officers to discuss road safety around the site. Please see the notes below:

- A parent at the meeting suggested the need for a controlled pedestrian crossing facility on Mile End Lane between the junctions with Granby Road and Seymour Road. Aside from the cost which could be in the region of £90K, a controlled crossing would also necessitate the removal of on-street parking fronting the residential properties on that side – which would be very contentious.
- The entry to the school near Seymour Road could be promoted as a crossing point with School Keep Clear markings (yellow zig-zags) and a dropped-crossing with tactile paving. The crossing point would be located on the wider section of footway (where pedestrian numbers accumulate) with visibility from Seymour Road.
- The school inform us that the entrance opposite Granby Road is now redundant; in which case the existing yellow zig-zags can be revoked. For the purposes of traffic management and to control congestion; it is recommended that the zig-zags are replaced with double yellow lines.
- <u>Lake Street / Sandhurst Road:</u> We are missing a pole and plate for the yellow zigzags at the school entry and the two bends can be consolidated with centre (hazard) lines to encourage cautious driving.

3. PROPOSALS

The proposed measures are delineated on drawing numbers: NM8-5173-001, NM8-5173-002 and NM8-5173-003.

4. LEGAL POSITION/IMPLICATIONS

The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

5. CONSULTATION

The School have been notified of the said proposals and have responded positively.

In local terms, these proposals should not be contentious as we are not proposing anything which will have a serious impact on nearby residents. Therefore, for the sake of expediency, a decision was made (in agreement with Councillors from both Wards) to report the measures directly to the respective Area Committees for approval. As and when the Traffic Regulation Orders are advertised by Legal Services, local residents (Inc. the School) will be notified and will have opportunity to return objections should they wish to do so.

If approved the measures are expected to be implemented in Spring 2022, subject to legal advertisement.

South East side from a point 17 metres North East of the (projected) North Easterly kerb line of Seymour Road for a distance of 43.5 metres in a South Westerly direction.

Extend No Waiting at Any Time:

Mile End Lane

South East side from a point 30 metres North East of the North Easterly kerb line of Granby Road for a distance of 38 metres in a South Westerly direction.
