1. MINUTES

3. URGENT DECISIONS

No urgent decisions were reported.

4. COMMUNITY ENGAGEMENT

(i) <u>Chair's Announcements</u>

The Chair on behalf of the Area Committee encouraged the Heatons and Reddish residents to get double vaccinated and the booster vaccine.

(ii) <u>Public Question Time</u>

Members of the public were invited to put questions to the Chair of the Area Committee on any matters within the powers and duties of the Area Committee, subject to the exclusions set out in the Code of Practice.

(iii) <u>Petitions</u>

No petitions were submitted.

(iv) Open Forum

A representative of Strategic Head of Service (Legal & Democratic Governance and Monitoring Officer) reported that no organisations had indicated that they wished to address the Area Committee as part of the Open Forum arrangements.

(v) Ward Flexibility Funding - United Stockport Circuit

A representative of the Strategic Head of Service & Monitoring Officer (Legal & Democratic Governance) submitted an application for Ward Flexibility Funding received on behalf of United Stockport Circuit towards the cost of setting up a Drive-In Carol Service over Christmas.

RESOLVED – That approval be given to an application from United Stockport Circuit for a grant of £200 from the Ward Flexibility Funding Budget (£50 from each ward allocation) towards the cost of setting up a Drive-In Carol Service over Christmas.

(vi) Ward Flexibility Funding - Friends of Reddish South Station

A representative of the Strategic Head of Service & Monitoring Officer (Legal & Democratic Governance) submitted an application for Ward Flexibility Funding received on behalf of Friends of Reddish South Station towards the cost of creating a V.E Day 1945 themed mural with the 1st/4th Reddish Beavers and Cubs, which will be placed at the station for 8 May 2022.

RESOLVED – That approval be given to an application from the Friends of Reddish South Station for a grant of £500 from the Ward Flexibility Funding Budget (£250 from Reddish North and £250 from Reddish South ward allocations only) towards the cost of creating a

V.E Day 1945 themed mural with the 1st/4th Reddish Beavers and Cubs, which will be placed at the station for 8 May 2022.

(vii) Ward Flexibility Funding - Arts Central Youth Theatre Group

A representative of the Strategic Head of Service & Monitoring Officer (Legal & Democratic Governance) submitted an application for Ward Flexibility Funding received on behalf of Arts Central Youth Theatre towards the cost of putting on a two night pantomime production in April/May 2022 and an end of year show in June/July 2022 for a theatre group for children in Reddish who cannot afford to join fee-paying theatre groups.

RESOLVED – That approval be given to an application from Arts Central Youth Theatre Group for a grant of £1,000 from the Ward Flexibility Funding Budget (£500 from Reddish North, £200 from Heatons North, £200 from Heatons South and £100 from Reddish South ward allocations) towards the cost of putting on a two night pantomime production in April/May 2022 and an end of year show in June/July 2022 for a theatre group for children in Reddish who cannot afford to join fee-paying theatre groups.

5. DEVELOPMENT APPLICATIONS

Development applications were submitted.

A representative of the Democratic Services Manager outlined the procedure approved by the Council for public speaking on planning applications.

(i) DC082006 - 20 Brook Road, Heaton Chapel, SK4 5BZ

In respect of plan no. DC/082006 for the refurbishment, alteration and extension of 20 Brook Road, comprising the erection of a single storey rear extension and a dormer roof extension.

A representative of the applicant spoke in support of the application.

It was then

RESOLVED – That planning permission be granted.

(ii) DC081304 - Land Adjacent to 6 Norfolk Avenue, Heaton Chapel, SK6 5AG

In respect of plan no. DC/081304 for the demolition of 4 No. residential garages and the erection of 1 No. three storey four bedroom dwelling with single garage.

A representative of the applicant spoke in support of the application.

It was then

RESOLVED – That the Planning & Highways Regulation Committee be recommended to grant planning permission subject to conditions being included relating to the strict controls over the construction activities at the site.

6. PLANNING APPEAL, ENFORCEMENT APPEALS AND ENFORCEMENT NOTICES

A representative of the Corporate Director for Place Management and Regeneration submitted a report of the Strategic Head of Service & Monitoring Officer (Legal & Democratic Governance) (copies of which had been circulated) listing any outstanding or recently determined planning appeals and enforcements within the area represented by the Heatons and Reddish Area Committee.

RESOLVED – That the report be noted.

7. MAYOR'S CYCLING AND WALKING CHALLENGE FUND, HEATONS ACTIVE NEIGHBOURHOOD TEMPORARY MEASURES

A representative of the Corporate Director (Place) and Deputy Chief Executive submitted a report (copies of which had been circulated) providing an update on the progress of the Heatons Active Neighbourhood scheme and to seek approval to retain some of the Heatons Active Neighbourhood measures on a temporary basis whilst further consultation and approval processes are undertaken.

The following comments were made/issues raised: -

- The Committee welcomed the report and were happy with the discussions around Ash Grove and have to date received positive feedback from local residents.
- It was commented that the trial has been well received in the community and welcomed the temporary extension to the 20mph speed limit and the one-way system.
- It was noted that some local residents were of the view that their concerns were not being listened to, but from the report and comments it is clear that those comments were listened to and acted upon.
- Propose to keep elements of the trial in Broadstone Road North.

RESOLVED - That the Cabinet Member (Economy and Regeneration) be recommended to approve the recommendation to retain some of

the Heatons Active Neighbourhood measures as detailed within paragraphs 4.1 - 4.7 of the report on a temporary basis whilst further consultation and approval processes are undertaken.

8. BUCKLEY STREET AND AIGBURTH GROVE, REDDISH

A representative of the Corporate Director (Place) and Deputy Chief submitted a report (copies of which had been circulated) addressing an anomaly at the junction of Buckely Street and Aigburth Grove in Reddish.

RESOLVED – That approval be given for the legal advertising of the following Traffic Regulation Orders and subject to no objections being received within 21 days from the advertisement date the following orders can be made:

Buckley Street

West side from a point 5 metres South of the Southerly kerb line of Aigburth Grove to a point 5 metres North of the Northerly kerb line of Aigburth Grove.

Aigburth Grove

Both sides from the Westerly kerb line of Buckley Street for a distance of 10 metres in a Westerly direction.

Introduce No Waiting at Any Time:

Buckley Street

West side from a point 5 metres South of the Southerly kerb line of Aigburth Grove to a point 5 metres North of the Northerly kerb line of Aigburth Grove.

Aigburth Grove Both sides from the Westerly kerb line of Buckley Street for a distance of 10 metres in a Westerly direction.

9. DRAKE COURT, REDDISH

A representative of the Corporate Director for Place Management & Regeneration submitted a report (copies of which had been circulated) providing details relating to partrevocations of No Waiting at any Time restrictions on parts of Drake Court in Reddish.

RESOLVED – That approval be given for the legal advertising of the following Traffic Regulation Orders at a cost of £910 to be funded from the Delegated Ward Budget and subject to no objections being received within 21 days from the advertisement date the following orders can be made:

Revoke No Waiting at Any Time:

Drake Court

South Easterly side from a point 6.5 metres North East of the North Easterly kerb line of Coronation Street for a distance of 3.5 metres in a North Easterly direction.

South Easterly side from the North Easterly kerb line of the cul-de-sac end for a distance of 4.5 metres in a South Westerly direction; including the return of 2.5 metres in a North Westerly direction.

Not forming part of the Traffic Regulation Order, the cost for a direction plate to No's 74 – 77 Drake Court.

10. HIGHWAYS MAINTENANCE AND LOCAL INITIATIVE REPORT PRIORY LANE

A representative of the Corporate Director (Place) and Deputy Chief Executive submitted a report (copies of which had been circulated) providing details of a proposed highway maintenance scheme on Priory Lane, Reddish – Footway Resurfacing to link path between Priory Lane and David Street at a cost of £7,500.

Councillor David Wilson welcomed the report and commented that it was in an area of a very popular school.

Councillor Kate Butler commented that the flooding in the area made it difficult to pass for those going to school and church and welcomed the report despite the costs and it being on an unadopted highway.

RESOLVED – That approval be given for the following proposed highway maintenance scheme to be funded by this Area Committee's Highway Maintenance and Traffic Management delegated budget at a cost of £7,500 and authorises the Deputy Chief Executive & Corporate Director for Place Management & Regeneration to order the work:-

Reddish North Ward

Priory Lane, Reddish – Footway Resurfacing to link path between Priory Lane and David Street – Totalling £7,500.00.

11. PROGRESS ON AREA COMMITTEE DECISIONS

A representative of the Strategic Head of Service & Monitoring Officer (Legal & Democratic Governance) submitted a report (copies of which had been circulated) updating the Area Committee on progress since the last meeting on decisions taken by the Area Committee and detailing the current position on area flexibility funding. The report also included the current position on the highway and traffic management delegated budget.
