Report of the Corporate Director for Place Management & Regeneration

1 INTRODUCTION AND PURPOSE OF REPORT

1.1 To approve the removal of the hatched area at the left of the bus stop to aid parking and to extend the bus stop markings to provide better visibility.

2 INFORMATION

2.1 Network Management have received representation from Councillor Wynne, Ward Spokesperson who has been approached by local residents who are concerned, particularly those with mobility issues, about regularly missing buses as the stop is set back away from the road. Vehicles are parked to the left of the stop which are obstructing lines of sight meaning passengers are unable to board as they only see the bus at the last minute and the driver does not spot passengers.

3 PROPOSALS

- 3.1 In order to improve the visibility of the Bus Stop, it is proposed to remove the area where the hatched markings are to the left of the stop and to see an introduction of a parking space, with the bus stop being extended by the same amount thus giving a larger stop and better approach visibility for both drivers and users alike, as indicated on the attached drawing number F/001. It is also proposed to have the trees crown lifted and the vegetation cleared from around the lighting column to give maximum lighting at this stop.
- 3.2 The associated cost for the attached measures will be £1,280.00 funded from the delegated Strategic Budget.
- 3.3 No consultation with residents was deemed necessary, as there are no residential frontages on this side of the carriageway, and no alteration to the amount of parking provision available.

4. TIMESCALES

If approved the lining and signing works can be expected on site in April 2022.
