Marsland Street & Water Street, Portwood

Report of the Corporate Director for Place Management & Regeneration

1. INTRODUCTION AND PURPOSE OF REPORT

To approve upgrading (and extending) No Waiting at Any Time restrictions to include a Prohibition of Loading on Marsland Street and Water Street in Portwood.

2. BACKGROUND

The Development Control Officer responsible for the Porsche Showroom and Service Centre Development (DC070913) contacted Network Management in relation to the parking restrictions around the site.

Currently there are No Waiting at Any Time restrictions (double yellow lines) on both sides of Marsland Street, and it has been noted that historically, Blue Badge holders frequently park on the north side of the street adjacent to the Tesco site. When the planning application was being examined, it was concluded that this could affect the ability of service vehicles to turn in and out of the Porsche site and as such it was concluded that loading restrictions were necessary to consolidate traffic management and access for Emergency Services. Note: There is a dispensation that allow vehicles displaying a Blue Badge to park for up to three hours on double yellow lines; but there is no such arrangement where a loading restriction is operational.

The Development Control Officer also made the following recommendations:

The Tesco site has ample car parking facilities for disabled drivers and therefore it is suggested that a loading restriction should extend to the junction at Great Portwood Street (i.e. to prevent a displacement of parked vehicles on Marsland Street displaying a Blue Badge).

In anticipation of the southern part of Water Street being opened-up for a new retail development, it would make sense to use this opportunity to make a Traffic Regulation Order so that restrictions can be implemented on-site as soon as necessary.

3. PROPOSALS

The proposed measures are delineated on attached drawing number: **4253-001**.

4. LEGAL POSITION/IMPLICATIONS

The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

5. CONSULTATION

As and when the Traffic Regulation orders are advertised by Legal Services, the adjacent premises will be notified and will have opportunity to return an objection(s) should they wish to do so.

6. FINANCIAL IMPLICATIONS

The associated cost for the Traffic Regulation Orders will be funded by the developer as part of the planning conditions.

7. TIMESCALES

The proposals on Marsland Street are expected to be implemented on site in 2022.
