1. Introduction and Background

- 1.1 The Third Quarter Update Corporate Performance and Resource Report (CPRR) provides a summary of progress in delivering the Council's priority outcomes since the mid-year report. In the case of the budget and capital updates, this covers the period since the Q2+ report considered at the last cycle of Scrutiny and Cabinet.
- 1.2 The CPRR includes an executive summary and performance analysis, along with the forecast out-turn position on revenue and capital. As Portfolio Reports for Q3 were focused on performance data, this provides the basis for the summary.
- 1.3 The Corporate Performance Dashboard is also published alongside the CPRR. This provides further detail for the suite of 'Corporate' measures analysed in Section 2 of the report, including trends, comparative data and commentary. A unique link to the Corporate Performance Dashboard is included in the body of the CPRR.
- 1.4 The CPRR is due to be presented to CRMG Scrutiny alongside the Mid-Year Portfolio Reports.
- 1.5 This report is also due to be considered by Cabinet on 15th March.
