Birkdale Rd / Amesbury Grove Pedestrian Dropped Crossing

Report of the Corporate Director for Place Management & Regeneration

1. INTRODUCTION AND PURPOSE OF REPORT

1.1 To seek approval for the introduction of a pedestrian dropped crossing on Amesbury Grove and its junction with Birkdale Road to aid accessibility.

2. BACKGROUND

2.1 SMBC have received representation by a local resident concerned about the accessibility on the southern side of Birkdale Road across the junction of Amesbury Grove, South Reddish.

There is no provision of a pedestrian dropped crossing facility at this location thus it is preventing mobility impaired users accessing Reddish Road. There are no planned works in the area or maintenance within this location on the footways in the near future.

There is also a problem with vehicles parking on the footway at this location which is obstructing visibility for pedestrians crossing at this junction and in turn is also obstructing mobility impaired users and pushchair users.

The ward spokesperson has agreed measures are required to improve the accessibility at this location and that we install a pedestrian dropped crossing here to aid pedestrians and mobility impaired users as well as to highlight the crossing point to help deter vehicles parking on the footway.

3. PROPOSALS

- 3.1. To introduce a pedestrian dropped crossing on Amesbury Grove at the south side of the Birkdale Road, as shown on **Drawing No. NM1-6348-000**, which will also aid the prevention of footway parking.
- 3.2. Consultation is not required due to the type of works.
- 3.3. The Council has a duty of care for the general public and to ensure the highway remains safe. Thus, the installation of the pedestrian dropped crossing will help with accessibility for members of the public and deter vehicles from parking on the footpath.
