# Safer Street Save Lives - Heald Green Shopping Centre 20mph Zone

Report of the Corporate Director for Place Management & Regeneration

#### 1. INTRODUCTION AND PURPOSE OF REPORT

1.1 For the Cabinet Member (Sustainable Stockport) to approve an experimental Moving Traffic Regulation Order (MTRO) for a 20mph Zone and the notification of Traffic Calming in the form of speed cushions. For the sake of expediency and in agreement with the Ward Councillors, this report has been presented to the Cabinet Member prior to the Area Committee meeting on 8<sup>th</sup> March 2022.

#### 2. INFORMATION

- 2.1 Following COVID advice from Central Government and with support from the Safer Streets Save Lives funding, in October 2020 temporary traffic calming measures were introduced into several District Centres across Stockport. The intention was to ensure residents could shop safely and visit businesses and restaurants while in the District Centres and to support these areas during the recovery phase from the initial COVID lockdown. Measures were introduced in Romiley, Marple which are being removed. Reddish and Gatley which are currently being retained.
- 2.2 These are proposed in the interest of public safety and the reopening of district centres/shopping centres and provide safer environment for social distancing.
- 2.3 As this is an experimental order the consultation run concurrently. It is proposed to carry out a formal consultation, including letter drop and signage for a period of three week in April / May 2022. The results of which will be reported back to area committee.

#### 3. PROPOSALS

The proposals are as show on drawing number 7000A27012(D12) And comprise of:

- 20mph zone along Finney Lane
- Associated signage
- Bolt down cushions

## 4. LEGAL POSITION/IMPLICATIONS

The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

#### 5. FINANCIAL IMPLICATIONS

Implementation of these proposals are funded from the Save Streets Saves Lives and reopening of the District Centres budgets.
