The application is for the purchase of three heavy duty Gazebos for use on the carnival field in Torkington Park to be 1) Control and information Centres, 2) The First Aid tent. The associations' original gazebos are quite old and not in good condition = no longer fit for purpose.

People at the Carnival in Torkington Park, including local residents, visitors, many being young people often in family groups, and volunteers. It would help them find event information, contact members of the management team, have a meeting point for 'lost persons' and in the event of injuries, access First Aid treatment.

#### 10(a) How Many Stockport residents will benefit?

Up to 3,000 who attend or visit the carnival, and persons having minor injuries.

#### 10(b) Are there any restrictions on who will benefit from the funding?

The two gazebos will belong to the Hazel Grove Carnival Association who may loan them to other local organisations from time to time for their own activities.

#### 11. Your Project's Budget

The Two Seasons heavy duty waterproof pop up Gazebos which are  $3m \times 3m$ , with side walls guy ropes have been identified as suitable, though other similar models are available. They weigh approximately 25Kg each – heavy enough to be stable whilst easy to handle.
