REPORT TITLE: PORTFOLIO PERFORMANCE AND RESOURCES –
ANNUAL REPORTS 2021/22

1. Introduction and Background

- 1.1 The Annual Portfolio Performance and Resource Reports (PPRRs) for the Inclusive Neighbourhoods and Sustainable Stockport Portfolios are presented for consideration by the Committee.
- 1.2 The reports provide a comprehensive summary of progress against portfolio priorities, performance indicators and budgets during the second half of 2021/22, with a specific focus on the fourth quarter (January to March 2022).
- 1.3 The PPRRs are based on the 2021/22 Portfolio Performance and Resource Agreements (PPRAs), which were considered by the Committee on 14 June 2021 and approved by Cabinet on 29 June 2021.
- 1.4 Members should note that these reports relate to the 2021/22 financial and municipal year and not the new Cabinet Portfolios for 2022/23. Draft PPRAs for 2022/23 are under development and will be submitted to the next meeting of the Committee in early September.
- 1.5 Out-turn performance data is reported where available. Provisional data is included in some cases, and the latest data is shown where the full-year figure is not yet available. Exception commentary is also included to provide context to the data.
- 1.6 A link is included to the web-based portfolio performance dashboard, where members can access further information on these measures, including longer-term trends and comparative data.
- 1.7 In order to ensure the timeliness of these reports, they are considered by Scrutiny Committees ahead of the Corporate Report (CPRR) being submitted to the Cabinet Meeting. This will also allow any significant changes or issues raised to be fed back alongside the Corporate Report at the Cabinet Meeting on 28 June.
- 1.8 Members are asked where possible to direct any detailed questions or requests for further information in advance of the meeting via the respective Democratic Services Manager to enable the timely provision of additional information.

2. Recommendations

Scrutiny Committee is asked to:

- a) Consider the Annual Portfolio Performance and Resource Reports;
- b) Review the progress against delivering key targets and budgets for 2021/22;

- c) Highlight key areas of and responsibility for taking forward corrective action to address any performance or resource issues;
- d) Highlight any significant issues or changes to be fed back to the Cabinet alongside the Corporate Performance and Resource Report;
- e) Identify how areas of strong performance and good practice can be shared in other services.
