TRANSPORT CAPITAL PROGRAMME UPDATE REPORT

Report of the Director of Place Management

1. Introduction

- 1.1. This report sets out that there are some updates required to the Transportation Capital Programme for 2022/2023.
- 1.2. On the 5th of April the Cabinet Member for Economy and Regeneration approved the initial programme for the Capital Programme 2022-23.
- 1.3. However, this did not identify the programme for all available funds that will be available in this financial period at that time. Since then, the Council has been allocated some additional funding from the City Region Sustainable Transport Settlement (CRSTS). This funding of £791k is from the Integrated Transport Block(ITB) which is intended to be used to fund small scale improvements including road safety and the promotion of more sustainable modes of travel in accordance with the CRSTS objectives.
- 1.4. There is an ITB allocation for each year of CRSTS, but the Leaders have already agreed that the first priority for this funding is to support bus franchising and this will be kept under review each year. There is also an intention to review the rational for the funding split between authorities to ensure it reflects the CRSTS objectives more closely in future years.
- 1.5. The CRSTS objectives are.
 - driving growth and productivity through infrastructure investment
 - levelling up services towards the standards of the best
 - decarbonising transport, especially promoting modal shift from cars to public transport, walking and cycling
- 1.6. It is proposed that a report on the proposed programme is taken to Scrutiny for comment before the Cabinet Member for Economy and Regeneration approves the final programme.
- 1.7. The final programme for this and our Greater Manchester Maintenance allocation (also now funded by CRSTS) has to be presented to a Greater Manchester officer group for a final review to ensure they are both in accordance with the overall programme objectives before funding is released to the local authorities.
- 1.8. The Government is monitoring the delivery of the CRSTS programme at GM level and expects that annual allocations will be spent within year they are allocated, and the proposed programme reflects this constraint.

1.9. Officers have been aware of a number of long-standing local issues they have investigated on behalf on local Members and/or have identified as part of routine inspections, and this information has informed the proposed programme for the additional funding with prioritisation by need. The programme also complements a number of existing schemes including those in the Cheadle Towns Fund, and Mayoral Challenge Fund thus increasing the effectiveness of the funding available.

- 4.1. Windlehurst Road Highway Improvement Scheme £40k
- **4.2.** Reddish Vale Road Drainage improvements -£70k
- **4.2.1.** Following Network Rail utilisation of Reddish Vale Road for bridge repairs there will be a Network Rail contribution to repair the road. This extra funding from the HIP budget will address the remaining drainage issues at the site. This drainage work being done now will make the best use of the funding being made available by Network Rail. It is intended to adopt the road once all the work is complete .
