# Annable Road, Bredbury - Proposed Traffic Regulation Order 'No Waiting At Any Time'

Report of the Corporate Director for Place Management & Regeneration

### 1. INTRODUCTION AND PURPOSE OF REPORT

1.1 To report the findings of a consultation exercise and to seek approval for the introduction of a Traffic Regulation Order (TRO).

### 2. BACKGROUND

2.1. Traffic Services received a request from the Local Highway Ward Spokesperson to investigate concerns relating to motorists parking their vehicles close to the entrance of the nearby 'The Weekend Day Centre for Dementia Care' at Ada Kay House, previously known as The Ada Kay Centre, and making it extremely difficult for vehicles to access/exit the Ada Kay House Car Park.

### 3. PROPOSALS

3.1. Due to the nature of the concerns, Traffic Services propose to introduce a Traffic Regulation Order (TRO) 'No Waiting At Any Time' (double yellow lines); these proposals are shown on **Drawing No. NM8-5184-01.** 

### 4. LEGAL POSITION/IMPLICATIONS

4.1. The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

# 5. CONSIDERATION OF ALTERNATIVE SOLUTIONS

5.1. No other alternatives were considered.

### 6. CONSULTATION

- 6.1. The Local Ward Councillors have been consulted and no adverse comments were received.
- 6.2. Greater Manchester Police have been consulted with and no adverse comments were received.
- 6.3. Affected frontages were consulted with together with the nearby Ada Kay House.

From a total of 13 No. letters delivered to residents/properties we received 5 No. responses. A total of 4 No. responses (80%) agreed with the proposals whilst 1 No. response (20%) disagreed with the proposals.

# Comments made by those residents in support of the proposals

Comments	Traffic Services Response
Parked vehicles sometimes make it impossible to access The Weekend Day Centre for Dementia Care, Ada Kay House.	It is anticipated that the introduction of the proposed Traffic Regulation Order will alleviate these problems.
There is a tree planted in the footpath, if this was removed it would make parking easier for residents. To my knowledge, maintenance has never been carried out in relation this tree. For health & Safety reasons I trimmed the lower branches last Autumn.	The removal of any tree is not within the remit of this scheme. Comments have been noted in relation to the maintenance of the tree and we would encourage residents to submit their concerns via the official SMBC website.
Sometimes families are forced to park in the road whilst visiting.	No one has an automatic right to park on adopted highway. It is an offence to park in such a manner to prevent the movement of traffic on the highway.
The junction of Brimelow Street onto Annable Road is a concern. Vehicles cut this corner at speed and this affects turning right into Annable Road. Junction markings need to be added to the road to show there is a 'give way' to traffic coming along Annable Road. There has been issues with delivery vans dropping parcels at residential houses on Annable Road.

Visitors and workers of Ada Kay House park on Annable Road when their car park is full.

Until recently, we have not had any problems. Can you remind these people that we are their neighbours and that they need to abide by the laws, driving on pavements is illegal, blocking gates is illegal, so when they want to stop the parking with yellow lines I suggest they comply first. We live here, they do not.

### NM8-5184-01 Rev A.

Moving Traffic Offences & obstructions in the carriageway should be reported to Greater Manchester Police for potential enforcement.

Rule 243 of The Highway Code states vehicles should not stop/park in front of an entrance to a property.

It is not uncommon for couriers to deliver parcels to neighbouring properties if the persons for whom they are for are not in.

It is anticipated that the introduction of the proposed Traffic Regulation Order will stop vehicles from obstructing access to and from Ada Kay House.

Following the comments received from residents during the consultation, and discussions with the local ward councillors, the proposals have been amended to include the introduction of Give Way Markings at the Brimelow Street/Annable Road junction. The revised proposals are show on **Drawing No. NM8-5184-01 Rev A**.

# Proposed (TRO) 'No Waiting at Any Time'

### **Annable Road - North Side**

From the projected building line of properties No. 10 & 12 for a distance of 16 metres in a north westerly direction.

# **Annable Road - South Side**

From a point 15 metres north west of the projected building line of properties Nos. 2 & 4 for a distance of 11 metres first in a north westerly, then south westerly direction.
