#### Lansdowne Avenue, Romiley - Proposed Traffic Regulation Order 'No Waiting At Any Time'

Report of the Corporate Director for Place Management & Regeneration

#### 1. INTRODUCTION AND PURPOSE OF REPORT

1.1 To report the findings of a consultation exercise and to seek approval for the introduction of a Traffic Regulation order (TRO) as shown in **Appendix A**.

# 2. BACKGROUND

2.1. Traffic Services received a request from the Highway Ward Spokesperson for the Bredbury Green & Romiley Ward to investigate safety concerns as it had been reported that vehicles are parking close to the junction, obscuring visibility and hindering traffic movement.

# 3. PROPOSALS

- 3.1. Due to the nature of the concerns raised, Traffic Services propose to introduce a Traffic Regulation Order (TRO) 'No Waiting At Any Time'. These proposals are shown on **Drawing No. NM8-5187-01**.
- 3.2. These proposals compliment Rule 243 of the Highway Code which states DO NOT stop or park within 10 meters of a junction.

# 4. LEGAL POSITION/IMPLICATIONS

4.1. The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

# 5. CONSIDERATION OF ALTERNATIVE SOLUTIONS

5.1. No other alternatives were considered.

#### 6. CONSULTATION

- 6.1. The Local Ward Councillors have been consulted and no adverse comments were received.
- 6.2. Greater Manchester Police have been consulted with and they have no objections to these proposals.
- 6.3. Affected residents have been consulted with.

From a total of 19 No. letters delivered to residents, 11 No. responses (58%) have been received. Of the responses received, 10 No. responses (91%) are in support of the proposals and 1 No. response (9%) does not support the proposals.

Comments made by those in support of the proposals:

Comment	Traffic Services Response
Double Yellow Lines will push parking further into the cul-de-sac.	This is very possible and not uncommon when parking restrictions are introduced. The aim of these proposals is not to prevent motorists from parking on Lansdowne Avenue and are more about protecting the junction, improving safety for all road users, and ensuring movement of traffic is maintained for those motorists using the junction. These proposals also compliment the Highway Code Rule 243 which states DO NOT stop or park within 10 meters of a junction.
Who will monitor/enforce the restrictions?	The Councils Parking Enforcement Team are responsible for patrolling the Borough and carrying out enforcement action against all vehicles they observe parked in contravention.
Residents wanted to stop a specific vehicle from parking on Lansdowne Avenue.	Vehicles cannot be 'singled' out. Whilst a vehicle is taxed, holds a valid MOT and is insured the driver may park it on adopted highway, providing it is not parked in contravention.

Comments made by those not in support of the proposals:

Comment Traffic Services Response	
Double Yellow Lines will cause congestion further down the Avenue.	This is very possible and not uncommon when parking restrictions are introduced. The aim of these proposals is not to prevent motorists from parking on Lansdowne Avenue and are more about protecting the junction, improving safety for all road users, and ensuring movement of traffic is maintained for those motorists using the junction. These proposals also compliment the Highway Code Rule 243 which states DO NOT stop or park within 10 meters of a junction.
