1. MINUTES

No declarations of interest were made.

3. URGENT DECISIONS

No urgent decisions were reported.

4. COMMUNITY ENGAGEMENT

(i) Chair's Announcements

The Chair on behalf of the Area Committee informed the Heatons and Reddish residents that: -

- Climate Action Now (CAN) There was £9000 available in every ward for projects that
 would reduce greenhouse gases in Stockport. Any group could apply for up to £500,
 and the CAN team have just announced that there was an additional tier to the Fund
 that could support larger projects in the ward.
- Vote of Thanks Councillor Jude Wells was thanked on behalf of the Committee for the work and commitment she has made to the Area Committee as well as in her role as Cabinet Member for Adult Social Care especially during the pandemic.
- Congratulations Councillor David Wilson was congratulated on behalf of the Committee having been agreed at the last Council Meeting to become the Mayor of Stockport for 2022/23.

(iv) Open Forum

A representative of Strategic Head of Service (Legal & Democratic Governance and Monitoring Officer) reported that no organisations had indicated that they wished to address the Area Committee as part of the Open Forum arrangements.

(v) Ward Flexibility Funding - Friends of Cheshire Theatre School

A representative of the Strategic Head of Service & Monitoring Officer (Legal & Democratic Governance) submitted an application for Ward Flexibility Funding received on behalf of Friends of Cheshire Theatre School towards the cost of towards the cost of representing Team England at the Dance World Cup which has 12,000 children around the world aged from 4 to 25 trying to qualify for the finals which is held annually in a different location. This year it is in San Sebastian in Spain.

RESOLVED – That approval be given to an application from Friends of Cheshire Theatre School for a grant of £840 from the Ward Flexibility Funding Budget (£360 from Heatons North, £200 from Heatons South, £160 from Reddish North and £120 from Reddish South ward allocations) towards the cost of representing Team England at the Dance World Cup which has 12,000 children around the world aged from 4 to 25 trying to qualify for the finals which is held annually in a different location. This year it is in San Sebastian in Spain.

(vi) Ward Flexibility Funding - St Martin's Church Heaton Norris

A representative of the Strategic Head of Service & Monitoring Officer (Legal & Democratic Governance) submitted an application for Ward Flexibility Funding received on behalf of St Martin's Church Heaton Norris towards the cost of hosting a community Jubilee party on Saturday 4th June 2022 within the grounds of St Martin's Church. The party will take the form of a community fun afternoon. There will be a number of different activities which will draw in different elements of the community both in the organisation and involvement.

RESOLVED – That approval be given to an application from St Martin's Church Heaton Norris for a grant of £1,000 from Heatons South ward allocation only towards the cost of hosting a community Jubilee party on Saturday 4th June 2022 within the grounds of St Martin's Church. The party will take the form of a community fun afternoon. There will be a number of different activities which will draw in different elements of the community both in the organisation and involvement.

(vii) Ward Flexibility Funding - St Mary's Ladies Circle

A representative of the Strategic Head of Service & Monitoring Officer (Legal & Democratic Governance) submitted an application for Ward Flexibility Funding received on behalf of St Mary's Ladies Circle towards the cost of hiring a minibus for four outings planned.

RESOLVED – That approval be given to an application from the St Mary's Ladies Circle for a grant of £500 (£250 from Reddish North and £250 from Reddish South wards allocation) towards the cost of hiring a minibus for four outings planned.

(viii) Ward Flexibility Funding - Belle Vue Brass Brand

A representative of the Strategic Head of Service (Legal & Democratic Governance and Monitoring Officer) submitted an application received on behalf of the Belle Vue Brass Band for a grant from the Ward Flexibility Funding Budget towards the cost of raising funds for new uniform.

RESOLVED – That the application from the Belle Vue Brass Band for Ward Flexibility Funding on this occasion be deferred to the next meeting and that the applicant be invited to attend to provide further information to the Committee.
